# WIND NOW SERVING AS SECRETARY OF VETERAN'S AFFAIRS

FORMER CHAPLAIN BRINGS AIR FORCE EXPERIENCE TO ROLE

OKMULGEE, Oklahoma – Muscogee (Creek) citizen Grover Wind has been named Acting Secretary of Veteran's Affairs. Wind was officially named via Commission of Executive Officer dated Oct. 12, he said he already has big plans to serve the Muscogee Nation's veterans.

Wind was formerly the Chaplain for the MN Department of Health, working closely with Secretary of Health Shawn Terry. Wind claimed he is spending time finishing up those projects with Health as he enters into the new position.

As an Air Force Veteran serving from 1971-1977, Wind said it is an honor to have this opportunity of service.

He has spent most of his professional career in sales and marketing as well as being an ordained minister. All of which, according to Wind, gives him the experience to handle the executive cabinet position.

Each Principal Chief nominates the cabinet's members at the beginning of each term. Stepping into this position seemed to be somewhat unexpected for Wind.

"It's an unfortunate situation the way it happened," Wind said.

Wind believes it is his established connection and previous work with the department that lead him here.

"Over the years, I have done quite a bit of work with the veterans," Wind said. "I think the Administration was aware of my involvement."

He stated he is the Chair of the Advisory Council for the Veterans Cemetery in which he has been a part of for the last seven years.

Wind has played a helping hand the last two years in making signs for Veterans Day that are displayed on the side of the road near the tribal complex.

Now in its beginning stages, Wind has helped to develop the Mvskoke Veteran Native Motorcycle Riders, a group that helps escort Veterans to their final resting place.

"This is a job that yes, I really look forward to being a part of," Wind said. "This was an opportunity for me to be able to service and help our Veterans further."


He said the VASO building has a quote on the front that he lives by, "Then, they were young – they defended us. Now, they are old – we protect them."

For the upcoming Veterans Day celebrations, Wind claimed he would like to do something special although it is a short timeline for him to initiate any new events.

Wind would like to extend his invitation to any Native or Native Veteran with respect for Veterans to join the Motorcycle Riders.

He also would like to remind those with Veteran family members to submit information for them to be recognized on the special day with a sign displayed on Highway 75 in Okmulgee.

# KING CONFIRMED AS FEDERAL JUDGE

LAUREN KING WILL BECOME FIRST NATIVE AMERICAN FEDERAL DISTRICT JUDGE IN WASHINGTON

OKMULGEE, Oklahoma – Muscogee citizen Lauren J. King has been confirmed with a 55-44 vote by the U.S. Senate. Upon taking her oath, she will become the first Native American federal judge for the state of Washington.

King was nominated by President Joe Biden in May and will serve the Western District of Washington.

Federal district court judges are nominated by the president, confirmed by the Senate and serve lifetime appointments upon good behavior

In the 231-year history of the federal courts, only four Native Americans, which includes King, have been appointed as federal judges.

She is a partner at Foster Garvey, P.C., formerly known as Foster Pepper PLLC, in Seattle. King practiced with the firm since 2012 and chairs their Native American practice group.

"We're thrilled to learn of the historical confirmation of Ms. Lauren King to a federal judgeship," Muscogee Nation Principal Chief David Hill said. "She has been a champion for Indian law, a warrior for sover-

eignty and is a proven example of leadership among her peers in the profession. When strong, Muscogee women make history, it's always a good day."

King is also part of the Mvskoke Reservation Protection Commission, which identify needs and offer solutions to strengthen sovereignty in the wake of the McGirt decision from the U.S. Supreme Court in 2020.

She has also served on the board of the Northwest Tribal Court Judges Association since 2015 as well as a member of the Seattle Indian Health Board from 2017-2019.

Born in Oklahoma City, King received her Juris Doctor in 2008 from the University of Virginia School of Law, where she was editorin-chief of the Virginia Journal of Law and Technology. She has also taught Federal Indian Law at Seattle University School of Law as an adjunct professor.

King is a member of New Tulsa Tribal Town and is of the Sweet Potato Clan. Her grandmother is the late Anna (Jacobs) King and her greataunt is former Muscogee (Creek) Nation National Council Representative Irene Cleghorn. Her great-grandfather John Jacobs was also a lawyer and served on the House of Kings and House of Warriors.

# SUPREME COURT UPHOLDS PRIMARY ELECTION RESULTS

NEW DATES FOR GENERAL ELECTION ANNOUNCED

OKMULGEE, Oklahoma – The Muscogee (Creek) Nation Supreme Court has upheld the MCN District Court ruling in Adam Jones and Lanissa Jack Melton's joint petition for Fraud and Irregularities in the 2021 Primary Election.

At the conclusion of the hearing held Oct. 21, the Justices issued an oral decision that sided with the lower court and ordered the MCN Election Board to certify the Primary Election results.

Oral arguments before the court centered around 1,248 absentee votes that could not be counted by the Election Board because they had arrived at the Okmulgee Post Office after the 11 a.m. deadline stipulated by MCN Code.

It is unknown what number of these late ballots were mailed on time by citizens or were only late due to postal delays.

At an Oct. 23 Emergency Session, the National Council passed NCA 21-116. The legislation amends MCN Code Title

19 subsection 1-102 entitled, "General Elections" and appropriates funds to expedite the return of absentee ballots. Rep. Darrell Proctor sponsored the legislation, which passed 15-0.

MCN Election Office released updated election information on Oct. 25.

The new 2021 General Election dates will be Saturday, Nov. 13 with early voting being held at the Nov. 9 and Nov. 10 from 7 a.m. – 7 p.m.

The four early voting locations are in Okmulgee at the Mvskoke Dome, in Tulsa at Tulsa Indian Community located at 8611 S. Union, in Okemah at Okemah Indian Community located at 1100 S. Woody Guthrie and in Eufaula at Eufaula Indian Community located at 800 Birkes Rd.

Absentee ballots for the General Election are expected to be mailed out to voters Thursday, Oct. 28.

# **HEALTH SEEKS PAY INFORMATION EXEMPTION**

LEGISLATION TO BE ADDRESSED NEXT MONTH

OKMULGEE, Oklahoma - The Muscogee (Creek) Nation Department of Health is seeking passage of legislation that would exempt them from publishing salaries of all Health employees.

Legislation introduced during an Oct. 13 Health, Education and Welfare Committee meeting amending MCN Code Title 37 Chapter 3 Subsection 301 entitled "Information to be Provided," was addressed.

The subsection language states within 10 days of February 25, 1989 and on July 31 each year thereafter the Principal Chief shall submit to the National Council a list of all tribal positions and names, grades and step levels of persons in those positions.

The language states the list shall be published in the "Muscogee Nation News," which is now referred to as the "Mvskoke News."

Legislation was originally passed in 1982 that required the Princi-

pal Chief to submit this information to National Council, which was amended in 1989 to include the information be published in the Muscogee Nation newspaper. The legislation was returned with a veto by Principal Chief at the time Claude Cox, but was overridden by National Council and has been in place as law ever since without any further amendments.

During discussion MCN Secretary of Health Shawn Terry said though he understands the hesitancy about asking for an exemption in publishing salaries of MCN Health employees, the department has started to experience a tremendous shortage of nurses, lab personnel and other specialists in the field due to the COVID pandemic and information being publicly available.

"We have started to experience that our competitors are starting to use this information that they can gather publicly to find out what our people are making and can outbid

MCN Health provided positions, names and compensation for publication for Fiscal Year 2020. However, a health pay schedule scale was not provided showing the monetary range of each position's salary.

Mvskoke Media sent questions via email to clarify if MCNDH uses the MCN pay scale schedule as well as requesting information about the number of employees lost due to the publication of MCNDH salaries.

MM received the following response from Terry:

"My intentions in the Oct. HEW was to alert to the National Council that posting medical professionals' salaries could result in other agencies using that information to recruit our nurses and other medical professionals. It was also my intentions to inform the council that there has been a constant struggle to retain nurses due to salary wars.

I am sure this is done primarily through nurses giving various health systems what they are making. The bottom line is we don't want other people knowing what our medical professionals are making.

I did not intend to imply that there [have] been specific cases of poaching due to any specific report."

When asked during the committee meeting by Tukvpvtce District Representative and sponsor of the bill Anna Marshall how MCNDH employees felt about the legislation, Terry answered that he had not asked

"Honestly, I haven't done any polling around it," Terry said. "I've never had any employee feel good about what they make out in the newspaper. This really was just as intended as we don't want our competitors picking off our employees."


Okmulgee District Representa-

tive James Jennings claimed other employees do not appreciate their salaries being posted.

"I'm at the point whether we exempt Health or repeal the whole bill," Jennings said.

Jennings also stated that with the time allowance of next year's publication not occurring until July 31, 2022, he would be in favor of postponing the legislation to get more input from other departments.

A motion was then made to postpone the legislation until next HEW Committee meeting on Nov. 10.

# **INDIGENOUS PEOPLES' DAY CELEBRATED THROUGHOUT MVSKOKE RESERVATION**

IPD RECOGNIZED LOCALLY, NATIONALLY

OKMULGEE, Oklahoma - Indigenous People around the country observed Oct. 11 as Indigenous Peo-

The second Monday of October has been observed as Columbus Day and designated as a federal holiday since 1971, but thousands of Indigenous people and their supporters have claimed the day back and celebrate it as Indigenous Peoples Day.

Indigenous Peoples' Day claimed its roots in 1977 at an international conference on discrimination sponsored by the United Nations. South Dakota was the first state to recognize the holiday in 1989.

Shortly after, the International Conference on Discrimination Against Indigenous Populations, a group sponsored by the UN, began having discussions about replacing Columbus Day.

The first presidential proclama-

tion of Indigenous Peoples' Day was issued on Oct. 8 by President Ioe

Biden also proclaimed the day as Indigenous Peoples' Day in recognition of tribal nations' resiliency and sovereignty.

"For generations, Federal policies systematically sought to assimilate and displace Native people and eradicate Native cultures. Today, we recognize Indigenous peoples' resilience and strength as well as the immeasurable positive impact that they have made on every aspect of American society," read the proclamation. "We also recommit to supporting a new, brighter future of promise and equity for Tribal Nations — a future grounded in Tribal sovereignty and respect for the human rights of Indigenous people in the Americas and around the world."

In the capital city of the Muscogee (Creek) Nation, an annual celebration was held on the Council House lawn in Downtown Okmulgee.

The gathering of Indigenous peo-

ple at the Okmulgee event was large in comparison to last year's mid-pandemic event.

Culture was on display from vendor's handmade beaded jewelry to purchase, to food that included Native dishes like sofke and frybread, from the Muscogee language speakers and musicians that performed.

The event kicked off with the Myskoke Honor Guard posting of the Colors and Flag Song.

A proclamation from Mayor Richard Larabee was read by Muscogee (Creek) citizen and City Council Member Marcus Jeffrey claiming the day as Indigenous Peoples' Day in the City of Okmulgee. Alongside Jeffrey was Muscogee (Creek) Nation National Council Okmulgee District Representative James Jennings.

The event was concluded with a social stomp dance, traditional songs and closing prayer.

Other local celebrations included the City of Muskogee's two-day event Oct. 10-11. This kicked off with an Indigenous Film Festival at the Roxy Theatre on the first evening. The morning of the holiday started with an Indigenous March and led to a day full of cultural experience.

# MANKILLER HONORED ON U.S. COIN, NAME CHANGES, **MOCCASIN MAKER FESSES UP**

MANKILLER QUARTER; SPORTS MASCOTS AND MONUMENTS, ANCIENT FOOTPRINTS

OKMULGEE, Oklahoma—O.K., from the top down. Indigenous Day was declared by the U.S. President, Joe Biden... "The Federal Government has a solemn obligation to lift up and invest in the future of Indigenous people and empower Tribal Nations to govern their own communities and make their own decisions."


Being the skeptical type, one has to wonder how that will take shape for the rest of his administration. We now have the first Native American as the Secretary of the Interior, a Native as the Assistant Secretary for Indian Affairs (nowadays that's a given) and a Native nominee for Director of the National Park Service. That's a pretty

It's good to see how the rest of the nation has been changing its perceptions of Native peoples and cultures. For instance, the late Wilma Mankiller will appear on the U.S. quarter. She was the first woman to be elected as Principal Chief of the Cherokee Nation and accomplished much in the advancement of her tribe and Native peoples across the country. The coin is expected to be circulated in 2022.

Turning to the world of sport... the "Indians" is gone. Bad grammar? No, the truth. The Cleveland professional baseball announced its intention to drop the old name and replace it with the "Guardians". The team announced the change takes place at the beginning of 2022. No more tomahawk chop?

Redhawks or Bison? What's it gonna be Union High School? Now is about the estimated date for a choice on a new mascot name. But, that's not all. After a choice is made, students will decide on what the mascot design will be. The Union school website reports, student are leaning towards "Redhawks". Student comment: "Union Redhawks! It's perfect, sounds so close to the original. Would also sound good during the fight song." O.K. that would work.

Final academically connected item: the mighty mental giant school, the Massachusetts Institute of Tech-

nology (MIT) is reconsidering how it deals with the legacy of one of its 1800s founders, Francis Amasa Walker. According to the scientific newsletter, PHYORG, Walker said, Indians were "an obstacle to the national progress" and concluded the country was justified in pushing Native Americans off their ancestral lands.

The DeKalb County Commission in Georgia has voted to remove a relic dating back to the 'Indian' Wars of 1836. An old muzzle-loading cannon has been sitting in a local park for a century or so. The Atlanta Journal reports activists say it was nicknamed the "Genocide Cannon" and called "a tasteless representation of the brutality suffered by the Muscogee people."

In a scene reminiscent of the 1970's, Native students and activists have occupied the offices of the Bureau of Indian Affairs at the Interior Department in Disneyland-On-The-Potomac and other

places. Indian Country Today (ICT) reports, the Indigenous people are protesting the development of fossil fuels and other resources on different tribal lands across the nation. Reminds me of my younger activist

Native News Online and several local news stations around here report that a non-Native man masquerading as a 'medicine man' has been sentenced to life behind bars for sexual abuse of an Indian child and illegally possessing eagle feathers and parts. Carl Ortner was convicted of child abuse after pretending to be a medicine man and committing the crimes.

The Chickasaw Nation is planning to build a resort/hotel on the 40 acres surrounding the new First Americans Museum in Oklahoma City. The idea is to have the new "OKANA" Resort and Indoor Waterpark complement the world-class museum. The development is projected to open in the late

spring of 2024.

The National Park Service reports, human footprints have been discovered at an ancient lake site that are 23,000 years old. Footprints discovered in the Tularosa Basin in New Mexico and west Texas areas have been scientifically dated back that far. Comments from that study say, "...that humans have been living in North America for at least 23,000 years - many thousands of years older than previously thought."

That would devastate the old land bridge dates and theories. Our people might have crossed the Bering Sea land bridge, but which way were they

Speaking of feet, have you ever worn a pair of moccasins made by Minnetonka? Did you know that a non-Native company marketed them? And they were actually made by factories in China and the Dominican Republic. # **OH MY GOURD!**

TUCKER FRIEND SETS STATE RECORD FOR LARGEST GOURD IN OKLAHOMA

TAHLEQUAH, Oklahoma-It was on the first day of April when Muscogee (Creek) citizen Tucker Friend began growing his bushel gourd that would later on become the largest gourd ever in the state.

The 16-year-old from Tahlequah has always had a green thumb, according to his mother Heidi Wilder who said her son would get help from his grandpa when it came to gardening. She said her son has been interested in horticulture since he was 11 years old.

"He wanted a cell phone and I figured he wanted to talk to his friends or play games, and the first thing he did was look up giant pumpkins and how to grow them," Wilder said.

He entered his first compe-

tition showing a pumpkin in

The competitions he entered, Friend found it was difficult to beat the state record with the pumpkins because it's hard to grow them large in

"Gourds are a little bit easier to grow and the state record number was a little smaller, so I decided to go after it," Friend said. "The reason I wanted to grow them real big is because whoever gets first place they get bragging rights over."

The last time the state record for the largest gourd grown was in 2020, but Friend beat it by nearly 100 pounds.

He took his gourd to the Oklahoma Giant Pumpkin Growers event in Claremore in September. Competing against other gourds, his outweighed the largest one by over 40 pounds. His gourd weighed in

at 215 pounds.

Before he started growing gourds, Friend had been watching a Michigan man Mark Clementz who grew a gourd that weighed just over a ton in

His goal is to set the world record next year, Steve Connelly sets the current record at 470



# **MUSCOGEE CITIZEN OPENS NEW BUSINESS DURING PANDEMIC**

CHARCUTERIE DIVAS WAS CREATED BY A MOTHER AND DAUGHTER'S WISH TO REMAIN CLOSE AFTER COVID-19 STRUCK THEIR FAMILY

COWETA, Oklahoma - Muscogee (Creek) citizen Jackie Schmidt and her mother Tammy Bohannon consider themselves the divas of charcuterie.

Charcuterie is the French word for deli, but it has become a popular form of eating prepared meat, cheese, fruits and vegeta-

The mother and daughter pair launched their business together in late January after being separated from each other for nearly

Schmidt previously worked for the tribe for 12 years before becoming a stay-at-home mom.

Bohannon operated in-home daycare for 11 years and stayed in operation through the pandemic until she became sick with COVID-19.

Schmidt's son has an asthma and autoimmune disorder, so even before her mother became sick, she was weary of being

Over the year, the mother and daughter, and even grandson, communicated via Face Time, phone calling and staying social distanced.

Schmidt and her son ended up contracting the virus through another source and were sick around the same time as Bohan-

"We couldn't protect ourselves," Schmidt said. "We couldn't see each other and we were both scared."

Schmidt and her son recovered quickly but Bohannon's sickness lingered for over two

It was during that period of their lives when Schmidt came up with the idea of preparing and selling charcuterie boards.

"I kept thinking, 'what can we do to get her (Bohannon) out of daycare that will help her make money and we get to spend time together," Schmidt said.

After discovering the idea, Schmidt said there was not much in her area that offered the ser-

"I thought we could do that," Schmidt said.

Once Bohannon recovered, she quit her daycare business and jumped on board with the business venture.

The pandemic continued to cause the women trouble when searching for a kitchen but they eventually found a space in Coweta where they could make their creations.

The Charcuterie Divas cater weddings, parties and make gifts with customized platters.

# **GRANT FUNDS TO AID VICTIMS PASSED THROUGH COMMITTEE**

LEGISLATION REGARDING MCNDH INFORMATION BEING REPORTED POSTPONED

The grant funds will be used to expand and enhance access to medication-assisted treatment services for persons with an opioid use disorder seeking or receiving MAT.

The United States government requires that all federally funded awards adhere to the Uniform Administrative Requirements, Cost, Principles, and Audit Requirements upon receipt and acceptance of the award

### TR 21-143

Authorizing the Gaming Operations Authority Board ("GOAB") to execute the Okemah Generator and Switch Gear upgrade project proposal with Building Electrical Systems, INC. ("BESCO"). Rep. Freeman sponsored the resolution, which passed 4-0.

The GOAB determined that it is necessary to commence a generator and switch gear upgrade project with Building Electrical Systems, INC. for Creek Nation Casino Okemah.

On Sept. 15, 2021 at a regular meeting GOAB passed Resolution No. 2021-40 approving the Proposal and requesting NC authorization.

### TR 21-144

Approving and authorizing the International Swaps and Derivatives Association, INC. 2002 Master Agreement with BOKF, NA "BOK". Rep. Freeman sponsored the resolution, which passed 4-0.

Sexual Harassment may include but is not restricted to using of one's position of power/authority in the form of quid pro quo and other forms.

### NCA 21-111

Authorizing an appropriation for the 2022 Mvskoke Art Market. Rep. Randolph sponsored the resolution, which passed 4-0.

The MCN Cultural Center and Archives plans to host the 2022 Mvskoke Art Market on April 23-24, 2022 at the River Spirit Resort and Casino.

A leveraged resource match in the amount of \$3,300,000.00 will be committed by the Nation through an appropriation. For the construction of the new facilities, NC authorizes the Principal Chief to prepare, execute and submit a grant application in the amount of \$1,000,000.00.

### NCA 21-114

Amending MCNCA Title 19 Subchapter 1-102, 3-108, 6-101, 7-303, 8-106, 8-108, 8-201, 8-209, 10-102, 10-103, 10-105, 10-108, 10-109 and 10-111, Entitled "General elections," "Dissemination of information," "Appearance of candidate's name," "Absentee ballot affidavit," "Time for issuing lists or certificates," "Lighthorseman to provide security for ballot boxes," "Time for filing contest or recount," "Petition for fraud or irregularities," "Request for absentee ballot," "Transmittal of ballot to voter," "Return of ballots," "Handling of returned absentee ballot," "Examination of signatures: removal of outer envelope" and "Counting procedures." Rep. William Lowe sponsored the resolution, which passed 9-4-2. Rep. Thomasene Yahola Osborn, Rep. Mark Randolph, Rep. Travis Scott and Rep. Robert Hufft voted no. Abstained by Rep. Jennings and Rep. Adam Jones.

MCN 2021 Primary Election was September 18, 2021. As of 11 a.m. on Sept. 18 the total absentee ballots accepted was approximately 905; approximately 1,248 additional absentee ballots were received a week and a half after the election. There is a need to provide a solution so that Muscogee (Creek) voters are not disenfranchised and every legally cast absentee ballot is counted for the 2021 General Election.

The date for the 2021 General election, subject to any court orders issued by the District Court or the

Supreme Court, shall be Saturday, Dec. 11, 2021.

Dissemination of information shall be the duty of the Election Board to disseminate information about any subsequent changes of dates and times, polling locations up to the Election Day. Appearance of candidate's name shall have any prefix, or title placed before the candidate's name. The letter (I) shall be listed beside the incumbent.

Absentee ballot affidavit an absentee ballot not already submitted to be casted. Under 8-106 through 8-209 changes the time slot from the Friday next following an election to 10 days. All absentee ballot requests must be in writing by the registered voter and received at least 30 days prior to any scheduled election.

Absentee ballots may not be mailed more than 26 days prior to election, except ballots outside continental limits to be mailed 40 days prior election. Returned ballots must be postmarked no later than two days prior election day. Two Election Board members and a member of Lighthorse administration shall pick up absentee ballot boxes from the post office at 4 p.m.






# Years Severed: 1942 - 1945


# George C. Dunn Sr.
