MCN Press Secretary Jason Salsman said the administration feels comfortable with the amount of research and mitigation that has been increasingly improving to make the decision to proceed with the Festival.

"We are still very much staying alert and doing all we can to stay cognizant of the fact that the pandemic is still going and there is a chance to get sick," Salsman said.

The numbers, according to Salsman, have been showing that the Nation is on the right track.

"We thought it was time," Salsman said.

The Festival is completely funded by the Muscogee (Creek) Nation with free fun for the whole family.

According to the post, festival events will include a fun fair, live entertainment, food vendors, fireworks, 5K run, rodeo, sports tournaments, and a

parade.

Unfortunately, there has not been a Festival Celebration since summer of 2019 due to the Coronavirus.

"I think everyone is excited to see that after two years of no festival that we are going to be having it again," Salsman said.

He feels it is huge step towards normalcy.

MCN APPOINTS FIRST SURGEON GENERAL

MCN SURGEON GENERAL WILL PROVIDE HEALTH INFORMATION FOR ALL WHO RESIDE WITHIN THE MVSKOKE RESERVATION

TVLSE, Oklahoma - The Muscogee (Creek) Nation Principal Chief David Hill and Secretary of Health Shawn Terry announced the appointment of Colonel Lance Frye, M.D. as the first surgeon general to serve the Nation.

Col. Frye, in his capacity as MCN Surgeon General will provide Muscogee (Creek) citizens, other natives, and non-natives that reside within the Muscogee Reservation the best information available on how to improve their health and reduce the risk of illness

According to Secretary Terry, the COVID-19 virus showed the Department of Health the benefit of introducing a General Surgeon to the Nation.

"Dr. Frye's credentials speak for themselves," Terry said. "As our surgeon general, Dr. Frye will focus on mobilizing our citizens to be active participants in their health and well-being, focusing on public health issues such as obesity, tobacco cessation, mental health, substance abuse disorders, nutrition and a number of other initiatives."

By creating a surgeon general post, the Tribe is seeking to

"The health of our citizens and the communities we serve are of utmost importance to my administration," Chief Hill said. "The implementation of this new role within our Department of Health further reflects this commitment."

Dr. Frye will play the same role as the U.S. Surgeon General does on the national level.

His background includes tribal citizenship with the Choctaw Nation, current state air surgeon and senior medial officer for the Oklahoma Air National Guard. Most recently, Dr. Frye OB-GYN served as the Oklahoma Commissioner of Health. During his tenure as the state's health commissioner, Frye led the pandemic response for the state.

It was tribe's commitment to improving health care options for rural communities that interested Dr. Frye.

"This dedication was clearly evident during the pandemic," Frye said. "I am proud to be a part of this innovative and progressive team, and look forward to building and implementing programs that lead to many healthy generations to come."

The announcement took place at the Council Oak Comprehensive Healthcare Center.

NATIONAL COUNCIL RECEIVES VETO

PRINCIPAL CHIEF VETOES LEGISLATION REGARDING USE OF THE ORIGINAL NAME AND SEAL OF THE NATION

OKMULGEE, Oklahoma - The Muscogee (Creek) Nation National Council received a veto from Principal Chief David Hill on Jan. 5 regarding TR 21-158 to uphold and enforce the official name and seal of the MCN.

The resolution was passed by the National Council in a 14-0 vote then returned from Chief, and passed again with full support from the Council.

The legislation came about almost a year later after the executive branch implemented the new logo and name on shirts, cups, and other merchandise.

Confusion came after dropping the (Creek) from the name, which caused former MCN NC Representative Adam Jones III to bring forward the legislation to help clarify the appropriate name usage.

Muscogee (Creek) Nation, Muscogee Nation, Creek Nation and even Myskoke, have been the most common used aliases for decades and with some Muscogee people having referred to themselves as Creeks for centuries.

In Section One, this legislation states, "The name of this Tribe of Muscogee (Creek) people shall be the "Muscogee (Creek) Nation", and is hereby organized under Section 3 of the Act of June 26, 1936."

The Nation's Constitution was not amended during this process that would codify the "Muscogee Nation" as the official name.

Section Two describes the political jurisdiction of the MCN is based on treaties made between the United States of America and the Muscogee (Creek) Nation.

The third section demands the Executive Branch not utilize any name, seal or likeness not consistent with Article I Sections 1-3 of the Muscogee (Creek) Nation Constitution for any communication or official correspondence without a Constitutional Amendment.

The resolution concludes that the name "Muscogee Nation", associated branding logo shall not be used for any purpose within the Muscogee (Creek) Nation, with the exception of "Muscogee Nation" being used on the Nation's tribal tags and in names of any businesses or entities of the Muscogee (Creek)

"Nothing in the use of the logo and the name "Muscogee Nation" is intended to replace the official seal and name," Chief Hill's veto message

Hill claimed the bill was in violation of Section One (a) of Article V of the Constitution.

"(Constitution) provides for the executive power to be vested in the Office of the Principal Chief," Chief wrote. "Through this power, I approved the Nation's Marketing & Tourism Department to develop, use, and promote for branding and marketing purposes a logo and the name "Muscogee Nation" to be used to help establish brand identity and loyalty with the general public who do business with the Nation."

The veto message states the bill infringes on the Constitutional authority of the Office of the Principal Chief while directing the Executive Branch to comply and not the other branches of Government.

"Nothing in the Constitution authorizes the National Council to enact legislation that directs the Executive Branch Departments and personnel to abide by certain Nation business and marketing practices over the objection of the Principal

Marketing & Tourism Director Kyle Lee worked closely with Hill in this development.

During the December Business, Finance and Justice Committee meeting prior to the passage of the resolution, former Rep. Lucian Tiger said that legislation for rebranding is something that should have come through the Council beforehand.

The Council had seen this before; Rep. Tiger mentioned how Chief Hill was on the BFJ committee at the time, when the use of "Mvskoke" was denied in commit-

"Someone directed you not to go through the Council," Tiger said to Lee. "If it passed through Council, then it should have went to the citizens before any rebranding should have taken place."

Lee claims it was a part of decolonizing the Muscogee name.

Tiger said the rebranding has had a major impact on the way the non-Natives and other Native tribes see us due to the fast-growing advertising of the "Muscogee Nation"

To protect the official name and seal, laws are being amended in support of the legal name.

Representative Proctor introduced legislation NCA 22-016, amending MCNCA Title 37, 1-101 Entitled "Official Muscogee (Creek) Nation Flag and Great Seal design and NCA 22-018, amending MCNCA Title 36, 3-108 entitled, "License Plate" in the February Regular Session.

The law was amended with the Council's full support in keeping the original name and seal on the flags that represent the Nation.

The "License Plate" change clarified that: each license plate shall bear the name, "Muscogee Nation" due to space limitations on the license plate and shall mean the "Muscogee (Creek) Nation."

This tournament is called the Inaugural Oklahoma Inter-Tribal Rising Stars Game to highlight not only Muscogee (Creek) students but all tribal students. The event was created to reward and honor those students of ORES schools hard work. The games will showcase and display student-athletes' talents and character.

The day will be family-oriented filled with basketball games and little activities between games for all. There will be concession available, prices for admissions and concession items will be affordable.

On the girls' bracket the visiting teams were Welch, Earlsboro, Varnum, Wilson, Braggs, New Lima and Copan. On the boys' bracket the visiting teams were Kinta, Earlsboro, Glencoe, Braggs, Mason, Copan and Midway.

Games played on the 18th started with the girls' consolation bracket with the Wilson Lady Tigers defeating the Braggs Lady Wildcats (48-37). Following the girls' game was the boys' consolation where the Braggs Wildcats defeated the Mason Bulldogs (45-32).

In the evening session on the 18th was the winner's bracket where the Welch Lady Wildcats lost to the Earlsboro Lady Wildcats (70-44). The outcome of the boys' game was a matchup between the Kinta Eagles and Earlsboro Wildcats. The Wildcats lost to the Eagles (49-42).

On the 19th, the first matchup was between the New Lima Lady Falcons and the Welch Lady Wildcats in the consolation bracket, where the Lady Wildcats won against the Lady Falcons (55-47). The second game was between the Copan Hornets and the Earlsboro Wildcats, where the Wildcats won (81-43).

JUSTICE SUPERNAW SERVING THIRD TERM

IUSTICE KATHLEEN R. SUPERNAW HAS BEEN CONFIRMED BY THE NATIONAL COUNCIL TO SERVE HER THIRD SIX-YEAR TERM

OKMULGEE, Oklahoma -Muscogee (Creek) Nation Supreme Court Justice Kathleen R. Supernaw has been confirmed by the National Council to serve her third six-year term, ending in 2028.

Justice Supernaw was nominated by Principal Chief David Hill and confirmed during the February Regular Session.

"It has been my honor and pleasure to serve on the Muscogee Nation Supreme Court since 2010. I thank Chief Hill and the National Council for their vote of confidence. I will continue to do my best to perform the responsibilities and uphold the integrity of the Court for another term," Supernaw said.


Justice Supernaw has retired from her private practice specializing in Indian Law where she provided legal services for several Oklahoma tribes and non-profit organizations.

Prior to her private practice, she worked in Washington, D.C., as a Department of the Interior senior staff expert in Indian affairs and trust reform advising the Deputy Commissioner of Indian Affairs, Assistant Secretary Indian Affairs, and other high level Departmental Officials.

Prior to her assignment to Washington, D.C., Justice Supernaw was a Trial Attorney at the Tulsa Field Solicitor's Office, Department of the Interior.

Justice Supernaw was also an Acting Administrative Judge for the Board of Indian Appeals, Office of Hearings and Appeals, Department of the Interior.

Her past work history includes serving as General Counsel for the Principal Chief of the Osage Nation, Special Appellate Tribal Court Judge, and Associate Clinical Professor and faculty member of the University of

Tulsa College of Law.

She also served as co-counsel with the Department of Justice in federal court and Departmental counsel in Interior's administrative forums.

She has advised the Bureau of Indian Affairs on such legal matters as tribal ordinances and constitutions, gaming, P.L. 93-638 contracts and self-governance compacts, trust land acquisition and realty matters, Indian oil and gas matters, law enforcement, reassumption of contracts/ compacts by the BIA, and financial and auditing matters.

Lastly, she examined property titles for the Department for proposed gaming and non-gaming trust acquisitions for Indian tribes and individuals.

Justice Supernaw's third term will end on June 30, 2028 and will require nomination and confirmation of the National Council.

DECOLONIZE DECATUR CALLS FOR MUSCOGEE ARTISTS

A GROUP OF SUPPORTERS HAVE BANNED TOGETHER TO FIGHT FOR REPRESENTATION IN THE COMMUNITY

DECATUR, Georgia - Local to the DeKalb County area, a group is advocating for Muscogee artists to step forward with their artwork to replace the removed 1836 "Indian War"

In the city of Decatur, the town square once displayed the monument of the weapon used to drive the Muscogee people out of their homelands.

A local activist group called Beacon Hill Black Alliance for Human Rights developed the Decolonize Decatur Committee specific to advocating for the cannon's removal.

"The forced removal of the Muscogee (Creek) Nation was one of the darkest chapters in the long history of white supremacy and settler colonialism that imbues every aspect of American History," the alliance groups said in a letter to the Dekalb County Commission.

After months of peaceful protesting and joining forces with the community and even students of the local high school, the cannon was removed but now leaves an empty spot waiting for Muscogee representation.

Chairperson of the Alliance Fonta High, claimed this initiative started in 2017 with a different monument in close proximity to the cannon.

The "Lost Cause" monument uplifted confederate soldiers that enabled and supported slavery of African Americans.

African Americans were brought to the Georgia area unwillingly to be enslaved after the Muscogee people were pushed out of their homes and down the Trail of Tears 200 years ago, according to the Beacon Hill Black Alliance

for Human Rights website. On the evening of Juneteenth

2020, the "Lost Cause" monument was taken down and then just a year and 3 months later, the cannon followed down with it.

Paul McLennan, member of the Decolonize Decatur Committee said the cannon suggested genocide among the native peoples.


The two statues were located centrally in downtown Decatur in the "square" right by the former courthouse, library and other regularly visited municipalities.

"We know that statues are intentionally placed in that kind of place which people are going to see them in large numbers," High said.

The committee is looking for a Muscogee Artist or even other recognized tribal citizens to help create the next Art for the People installation.

GATHERING OF NATIONS SEEKS NEXT INDIGENOUS AMBASSADOR

ALBUQUERQUE, New Mexico-The Gathering of Nations Powwow is coming up and with that in mind so is the Miss Indian World Pageant. The pageant is seeking contestants to represent the Gathering of Nations (GON) and all Indigenous pop-

According to the GON website, the Miss Indian World Pageant is the largest and most prestigious cultural title for young Native/Indigenous women. Miss Indian World is a Cultural Goodwill Ambassador to all cultures presenting and representing Native American, Indigenous and First Nations tribal culture.

Miss Indian World first originated in 1983 in Albuquerque, NM. She is selected by acquiring points in a variety of categories and must be knowledgeable about the tribe(s) and traditions she will be representing.

Even though this is a fiveday competition, the contestants will experience a journey of sisterhood as they represent their tribes and communities, form lifelong friendships and memories, participate in a full stage production of the Miss Indian World traditional talent presentations, and take place in the crowning of the new ambassador in front of an audience. She will hold the reign for

To qualify for the competition, contestants must be natural born female Indigenous woman ages 18-25 (cannot be older than 25 at the time of the crowning), must verify tribal

affiliation, single/never married, no dependents (as the Miss Indian World travels and represents all Native Americans) and must have knowledge of tribal traditions.

Tulsa welcomes back the Professional Bull Riders (PBR) elite Unleash The Beast, holding the PBR Express Ranches Classic presented by Hard Rock Hotel and Casino.

ments in PBR history."



OKMULGEE, Oklahoma -The Muscogee (Creek) Nation National Council meeting was held on February 26 via telecon-

The Council addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 22-018

Authorizing the construction of an Emergency Department Expansion at the Muscogee Nation Medical Center in Okmulgee, OK on behalf of the MCN Department of Health. Representative Joseph Hicks sponsored the resolution, which was adopted, 14-0.

The MCNDH desires to construct an expansion to the Emergency Department at the Muscogee Nation Medical Center in Okmulgee, OK.

TR 22-022

Authorizing the Principal Chief to submit a Grant Application to the U.S. Department of Interior, Bureau of Indian Affairs, Fiscal year 2022 Living Languages Grant Program for the Myskoke Language Program. Rep. Anna Marshall sponsored the resolution, which was adopted 14-0.

The program wishes to further document and expand access of the Mvskoke language by making resources available. The grant will be in the amount of \$200,000.

TR 22-023

Confirming the nomination of Grover Wind as the Office of Veterans Affairs Services Administrator of the MCN. Rep. Robert Hufft sponsored the resolution, which was adopted 14-0.

Principal Chief has nomination Wind to serve a term ending concurrent with his.

TR 22-024

Authorizing the Principal Chief to execute a request for use of an auditorium with Beggs Public Schools. Hufft sponsored the resolution, which was adopted 14-0

MCN Youth Services Program and Myskoke Tribal Child and Youth Council seek to use the auditorium for various events and programs throughout the fiscal year.

TR 22-025

Authorizing the Principal Chief to execute a memorandum of agreement with the Mississippi Department of Archives and History. Rep. Charles McHenry sponsored the resolution, which was adopted 14-0.

MDAH has plans to construct a new museum honoring the Natchez Indians, affiliates of MCN, and desires to partner with MCN for the museum.

TR 22-026

Authorizing the Principal Chief to execute a memorandum of agreement with Bearden School District for the construction of a parking lot. Rep. Thomasene Yahola Osborn sponsored the resolution, which was adopted 14-0.

The Nation Tribal Transportation Program will fund \$425,000 to construct an asphalt parking lot with drainage improvements to Bearden School.

TR 22-027

Authorizing the Principal Chief to execute a memorandum of agreement with the College of Muscogee Nation for the construction of a parking lot. Rep. Marshall sponsored the resolution, which was adopted 14-0.

The MCN Tribal Transportation Program will fund \$440,000 to construct an asphalt parking lot with drainage improvements at CMN.

TR 22-028

Authorizing the Principal Chief to submit a 2022 Invasive Species Program Grant Application to the Bureau of Indian Affairs. Rep. McHenry sponsored the resolution, which was adopted 14-0.

The grant in the amount of \$243,555 will assist the Nation's Department of Natural Resources to capture, hold, or remove feral or wild animals to promote the growth of native vegetation.

TR 22-029

Authorizing the construction project of the Tulsa Head Start parking lot. Rep. McHenry sponsored the resolution, which was adopted 14-0.

The Nation's Tribal Transportation Program will fund \$430,000 to construct an asphalt parking lot at the Tulsa Head Start.

TR 22-030

Authorizing the construction project of the Fleet Services parking lot. Rep. McHenry sponsored the resolution, which was adopted 14-0.

The Nation's Tribal Transportation Program will fund \$530,000 to construct a parking lot at the Fleet Services.

TR 22-031

Authorizing the Principal Chief to apply for federal funding through the Federal Highway Administration to complete an Environmental Assessment, Hydraulic Study and Design a replacement bridge for fifteen bridges in six counties with the MCN reservation. Rep. McHenry sponsored the resolution, which was adopted 14-0.

The total funding in the amount of \$1,637,000 is being requested to prepare plans, specifications, estimates, hydraulic studies and environmental assessments.

TR 22-032

Approving the Rental Subsidy Program for the MCN Department of Housing. Rep. Galen Cloud sponsored the resolution, which was adopted 14-0.

MCN Department of Housing seeks to adopt and implement a policy designed to serve as a guide for the Rental Subsidy Program.

TR 22-033

Confirming the nomination of Kathleen Supernaw to serve as a Supreme Court Justice of the MCN. Rep. Mark Randolph sponsored the resolution, which was adopted 14-0.

U.S. Department of Interior Bureau of Trust Funds Administration (BTFA) must meet the requirement of the Trust Reform Act before the sale of a government bond can be processed with a resolution.

In compliance with the Trust Reform Act and 25 C.F.R. when the Muscogee (Creek) Nation wishes to sell a security investment, it must state in writing to the local BTFA. The Nation's Controller shall provide a written request to the Fiduciary Trust Officer at the local BTFA.

TR 22- 035

Nominating Lisa Otipoby-Herbert to serve as a District Trial Court Judge of the Criminal District Trial Court Law Division of the MCN. Rep. Randolph sponsored the resolution, which was adopted 11-3 with Rep. Joyce Deere, Joe Hicks, and Marshall voting no.

Principal Chief nominated Lisa Otipoby-Herbert to serve as a District Trial Court Judge of the Criminal District Trial Courts.

TR 22-036

Authorizing the construction of the Tribal Master Site Plan Capitol Complex Projects for the MCN. Rep. Cloud sponsored the resolution, which was adopted, 11-3. Reps. Sandra Golden, Marshall and McHenry voted no.

The project will consist of five new buildings and other associated site elements and infrastructure, as required to support the facilities and connected existing buildings with central plazas, sidewalks, outdoor gathering space, etc., in order to implement a connected, walkable and safer campus as described in the MCN Master Site Plan.

TR 22-037

U.S. Department of Veterans Affairs has entered into a partnership with the VHIT LLC to convert the existing Kerr-Edmondson office complex into a new 58-bed Veterans Hospital; this is within the Muscogee Reservation.

TR 22-039

Approving liquor sales at the Tulsa Creek Indian Community Smoke Shop. Rep. Hufft sponsored the resolution, which was adopted 14-0.

Tulsa Creek Indian Community Smoke Shop is seeking licensing through the Nation to sell liquor and beer.

TR 22-040

Authorizing the Principal Chief to execute a first amendment to revolving loan and security agreement with BOKF, NA d/b/a Bank of Oklahoma and an amended and restated revolving note with BOKF, NA d/b/a Bank of Oklahoma. Rep. Cloud sponsored the resolution, which was adopted 13-1 with Rep. Sandra Golden voting no.

The Nation wishes to increase the loan agreement from \$75 million to 125 million for the Tribal Master Plan Capitol Complex Project.

TR 22-041

Approving the MCN Tribal Master Site Plan Capitol Complex Project. Rep. Cloud sponsored the resolution, which was adopted 14-0.

The project will consist of five new buildings and other associated site elements and infrastructure, as required to support the facilities and connected existing buildings with central plazas, sidewalks, outdoor gathering space, etc., in order to implement a connected, walkable and safer campus as described in the MCN Master Site Plan.

Amending NCA 21-156 (Approving and authorizing the Principal Chief to execute and file articles of organization with the Office of the Secretary of the Nation to form "Muscogee Nation Gaming Enterprises, LLC" Under the MCN Limited Liability Company Act and Approving the Operating Agreement for "Muscogee Nation Gaming Enterprises, LLC). Rep. Yahola-Osborn sponsored the legislation, which was adopted 14.0

MCN finds its best interest to organize a tribal gaming limited liability Company wholly owned by the Nation, as an instrumentality of the Nation, created for the purpose of operating and managing gaming in furtherance of the governmental objectives of the Nation for the advancement of its members.

NCA 22-018

Amending MCNCA Title 36, 3-108 entitled "License Plate". Rep. Proctor sponsored the legislation, which was adopted, 14-0.

The code was changed to clarify that each license plate bearing the name Muscogee Nation shall mean the Muscogee (Creek) Nation and is shortened due to space limitations.

CONSTRUCTING THE REZ

TRIBAL CONSTRUCTION DEPARTMENT HAS LAID FOUNDATION FOR CONSTRUCTION AROUND THE RESERVATION

OKMULGEE, Oklahoma -The Muscogee (Creek) Nation Tribal Construction Director Steve Emerson gives an update on the many projects happening all over the reservation.

Where the Highway 56 Loop meets Highway 62 in Okmulgee, the new Behavioral Health Facility is still undergoing construction, Emerson said.

Emerson claimed the 26acre property, known as the former Sewell property was purchased a couple of years ago by the Nation for the Health Department's Master Plan to build a new healthcare clinic to serve the Okmulgee area.

According to Emerson, this 5800 square foot building designed by Childers Architect LLC brings originality for the future offices and patients that will receive services.

"It's got all the bells and whistles, very well designed, high-end construction," he

Emerson claimed the building is projected to be completed by the end of March 2022 and the Behavioral Health staff to relocate services there in early April 2022.

This project will be completed on schedule and on budget, according to Emerson.

Emerson said the Federal Roads Maintenance Building is winding down its construction phase.

The 5,000-square-foot build will include a five-bay maintenance equipment storage that Emerson says his department is excited for its usage during cold weather.

"We wished that it was finished two weeks ago," he said jokingly referring to the winter storm that covered the Reservation. "We have never really

had a facility to keep our equipment, even though it's a small project and insignificant to everybody else, it's real important for our us."

The department has been frequently meeting with College of Muscogee Nation President Dr. Monte Randall and Regents Director for Institutional Effectiveness Dr. James King for the 14,700-square-foot Lecture Hall STEM Facility located at the College of the Muscogee Nation.

The facility will be designed by Anishinabe Design and will be mostly uniform with the rest of the CMN campus, according to Emerson.

Designs will include implementation of Mvskoke language and culture throughout the facility.

"We look to break ground and start construction on that project in June," Emerson said. "It will take about 14 months to complete it."

Currently, the department has hired a construction management company to work with Anishinabe on pricing materials and things needed for the project for approval of the GMP or guaranteed maximum price.

Another upcoming project will be a Wellness Center located at the Reintegration Program campus in Henryetta.

This facility will offer the program participants to have a place for recreational activity.

Emerson said the initial grant funding for the center does not cover the design plans the RIP has developed for this

Design plans include a fullsize basketball court and a place to gather, although design plans are not final.

"Right now the design that we have is about 8,400 square feet," he said. "I am excited to try to get that one started."

Located on the Mission St. in Okmulgee near the CMN campus and the MCN Complex, Three Ponds Elderly Housing is in its finishing stages.

Emerson claimed this is a huge project that his crew performed the dirt work on removing over a million pounds of dirt.

The Tribe's Master Plan is in its very beginning stages which is something construction department will have a heavy hand in starting with developing an entrance into the complex from Highway 75.

The Tribal Construction Department oversees all construction projects over the Reservation. It is Emerson's primary role to interview potential companies and contractors for the construction projects as well as implementing his immediate crew to perform smaller tasks included in project plans.

The department uses CESO preferences and Native American owned businesses while implementing Mvskoke culture in each build.

This small crew has a variety of skills between them including office staff who do design and development, heavy equipment operators, a CDL driver.

"They do a lot of work for the Nation," Emerson said. "They save us a lot of money and to make the money go further, we perform a lot of the dirt work."

In his five years working with the tribe, Emerson has learned more about his culture and has had the opportunity to work with almost every depart-

"That's the best part of my job," he said. "About 50% of job is working with other departments."


Emerson said he sees the tribe growing even more over the next five years.


In Memoriam


