MMIP AWARENESS DAY PROCLAIMED AS MAY 5

AWARENESS OF MMIP EFFORTS ARE NOW FEDERALLY RECOGNIZED

Okmulgee, Okla. - The Muscogee Nation Center for Victim Services walked through the MCN Complex on May 5 to honor, remember and raise awareness for Missing and Murdered Indigenous People. On the same day, the U.S. Department of Justice proclaimed the day as National MMIP Awareness Dav.

The statement from the U.S. Department of Justice details the recognition of the day, as well as statistics on the MMIP crisis.

"Missing or Murdered Indigenous Persons Awareness Day calls on our nation to pause and honor the loved ones who have gone missing or who have been the victims of violent crime," U.S. Deputy Attorney General Lisa O. Monaco said in the proclamation.

According to MCN CVS Health and Wellness Coordinator Morgan James, spreading awareness is important when it comes to MMIP.

MCN works closely with MMIP chapters across the state to spread awareness.

President Biden released a proclamation the day prior.

"Indian Country has been gripped by an epidemic of missing or murdered Indigenous people, whose cases far too often go unsolved," President Biden stated. "Families have been left investigating disappearances on their own, demanding justice for their loved ones, and grieving pieces of their souls."

The proclamation outlined the work his administration has done on the issue, with a big credit going toward U.S. Secretary of the Interior Deb Haaland for her role.

The proclamation follows the two-year anniversary of Haaland's announcement of the Bureau of Indian Affairs Missing and Murdered Unit, which was developed to focus specifically on cases involving Native American vic-

In 2016, there were 5,712 reports of missing American Indian and Alaska Native women. The National Missing and Unidentified Persons System did not accurately reflect the amount of reports made. Only 116 individuals had been logged into the

These numbers shed a light on the crisis Native women face across the United States. This later opened the door for awareness on the numbers of Native men who have either gone missing or have been murdered.

This defined the problem as a public health crisis.

In 2021, U.S. District Attorney Trent Shores disclosed information on Myskoke Radio stating that in Oklahoma there are more cases of missing Native men than

According to the BIA website, current statistics show that approximately 1,500 American Indian and Alaska Native missing persons have been entered into the National Crime Information Center (NCIC) throughout the U.S. Approximately 2,700 cases of murder and nonnegligent homicide offenses have been reported to the federal government's Uniform Crime Reporting (UCR)

The BIA estimates that there are approximately 4,200 miss-

ing and murdered cases that have gone unsolved.

MMIP cases can be viewed on the BIA website.

These cases remain unsolved due to the lack of available resources for local law enforcement agencies. This includes investigative resources to identify new information from witness testimony, re-examining new or retained material evidence, as well as reviewing fresh activities of sus-

The first congressional reso-

lution to declare May 5 as MMIP Day was issued in 2017. The date of May 5 was selected after the Montana congressional delegation persuaded the U.S. Senate to pass a resolution declaring the national day of awareness to honor the birthday of Hanna Harris, a 21-year-old member of the Northern Cheyenne tribe who went missing on July 4, 2013 and never returned home.

BACONE ACCREDITATION COMPLAINT FILED

FORMER STAFF ALLEGES MISMANAGEMENT

Muskogee, Okla. - Bacone College was established in 1880 and has historically been an institution that educates Native Americans.

The college recently lost a \$1 million judgment in Muskogee District Court because it did not pay a construction company for work done on its facilities.

A complaint concerning Bacone College's accreditation was filed with the Higher Learning Commission (HLC).

HLC is an independent corporation that grants accreditation to degree-granting, post-secondary educational institutions in the United States. Accreditation is necessary to ensure that credits acquired by students at a college can be transferred to other institutions, and are of a certain level of quality.

HLC has a process in place for students, faculty, staff or members of the public to submit a complaint if they

believe that there are problems with the institution's ability to meet the criteria of accredita-

Complaint Letter

Mvskoke Media was provided a copy of the complaint filed by the former Bacone Senior Director of Student Support Services Kendall Scott (Kickapoo).

The 81-page complaint paints a picture of an institution in crisis. It contains examples of Bacone faculty, staff, and students violating policy without repercussions.

The complaint claims that Bacone's finances are in ruins, with payroll, benefits and basic utilities not being paid for months, if at all.

Events in the complaint cover the time range spanning from March 2021 to March 2023.

The complaint alleges that Interim President Dr. Nicky Michael (Lenape) dissolved all of the school's committees except the executive commit-

Incidents involving stu-

dents' belongings being damaged or stolen are detailed in the complaint.

It also alleges that Bacone relied heavily on recruiting student athletes, with Bacone college coaches regularly promising amenities that they knew the school could not provide.

In addition, the complaint contains the resignation letter of Rhonda Barron (Chickasaw), an educator at Bacone. The letter reads as follows.

"Without regret, I am submitting my letter of resignation. In the 22 years I have been an Educator, I have never experienced the lack of transparency I have experienced at Bacone College.

Since the day I walked into Bacone, I felt the protective need to safeguard all that Bacone stood for. The history behind Bacone and the Native Indian students that have come here since 1880. Since the day I walked into Bacone, I have also been immersed in a political power struggle that has affected students and staff alike. This fight was not mine. I was constantly being approached to side against the administration at that time (Ferlin Clark's). From the very first day, it felt like an explosive place to work. Since the removal of Dr. Clark, it has only grown worse. (More details of current administration abuse will be sent to appropriate agencies.)

I can no longer stand by and see the injustice I have witnessed here. From the lack of resources to the mismanagement of students, finances, and staff. The deceit is deep. I am ashamed for not stepping up earlier and saying something sooner.

To the Board:

You are responsible for making Bacone something to be proud of. I am embarrassed to tell people I work at Bacone.

You have the power to step up and see what is happening, yet I have never met any of you. You fail as a board of Directors. You have not invested in making Bacone a better place to work and attend as students. I frankly don't understand what purpose you do serve. You hear what you want to hear, but you do not come and see what you would see.

As a Chickasaw Citizen and a proud Native American, I choose to stand up now and say something when I see something.

A detailed letter of the abuse going on at Bacone will be submitted to the Chickasaw Times, Muskogee Phoenix, and to the Chickasaw Nation immediately following the submission of this resignation letter."

Barron submitted her letter to an online news outlet, "Muskogee Now", who published it under the headline "Educator alleges crumbling conditions, warring staff, financial struggles at Bacone" on April 26, 2022.

Alleged Clery Act **Violations**

The complaint also details how Bacone was fined \$200,000 for Clery Act violations.

The Clery Act is a federal law that requires colleges and universities to report campus crime data, support victims of violence and publicly outline the policies and procedures they have to improve campus safety.

Myskoke Media contacted the Department of Education, but was unable to verify that Bacone was fined.

Mvskoke Media spoke with Bacone Interim President Dr. Nicky Michael and Chief Operations Officer Dr. Leroy Thompson about the allegations outlined in the report.

"We definitely have had previous administrations that have put the school in jeopardy and there is a very large amount of debt," Michael said.

Michael had previously served as Bacone's Executive Director of Indigenous Studies and Curriculum under President Ferlin Clark, from August 3, 2020 until March 2021 when she was placed in the Interim President position.

"When I came into the position, mind you, I was the chair of the American Indian studies, I was asked to step into this position, I did not seek it, and I really wouldn't wish this on anybody. It's a very huge task and it's been one day after another, kind of unearthing and un-layering of some of the past wrongdoings and misadministration." Michael said.

Scott, author of the HLC complaint, spoke to Mvskoke Media about why he filed the complaint.

"When I left Bacone College I was getting a lot of emails and text messages from students saying 'hey, they're not taking care of us you know'. When Ferlin (Dr. Clark) was in charge we had shared governance, executive committee and a committee for student violations. But when Nicky got in charge she disbanded all the committees except for the executive committee," Scott said. "Basically Nicky came in and disassembled all of the regulations that we typically follow for the HLC, during the probation period we were put on probation and we needed to rewrite all of our policies and procedures and we spent the whole summer prior to Ferlin leaving rewriting the faculty handbooks and (student) handbook. We had rewritten them and then we didn't follow them. As soon as Nicky got in charge we didn't follow the policy and procedures for the student handbook and the faculty handbook."

Bacone had previously been put on accreditation probation by HLC in February 2019.

The college spent the next 3 years working to attain HLC compliance and officially regained accredited status in February 2022.

According to Scott, Dr. Clark's leadership as Bacone President was instrumental in getting Bacone off of accreditation probation with the Higher Learning Commission.

HLC has responded to Scott's compliant with a letter

"Upon initial review of your complaint, HLC determined that the matter regarding Bacone College raises potential concerns regarding the institution's compliance with the Criteria for Accreditation and certain other HLC requirements. Due to these potential concerns, HLC will conduct a further review of the institution based on your complaint. HLC will forward your complaint to the institution for formal review and response. The institution will then have 30 days to respond to the concerns in writing and provide appropriate supporting evidence.

HLC will review the institution's response to determine what action, if any, is needed based on the evidence. The Commission, however, is unable to provide any further updates on the status of the review of your complaint beyond the information included here. If HLC's continued review of this complaint leads to a formal evaluation of the institution, including the scheduling of an Interim Report, Focused Visit, or other such evaluation, it will be published on the institution's Statement of Accreditation Status (SAS)."

Mvskoke Media will have continuing coverage of this developing story.

SCOTUS RULES ON TWITTER CASE

DECISION STATES THAT THE PLATFORM DID NOT "AID AND ABET" ISIS

Washington, D.C. - The United States Supreme Court issued decisions in Gonzalez v. Google and Twitter, Inc. v. Taamneh on May

An in-depth look at each case was also published in the March 15, 2023 edition of the Mvskoke

In an unanimous opinion written by Chief Justice Clarence Thomas, the court ruled that Twitter did not "aid and abet" Islamic State terrorists by allowing them to use the service.

According to the opinion, "As alleged by plaintiffs, defendants designed virtual platforms and knowingly failed to do 'enough' to remove ISIS-affiliated users and ISIS related content—out of hundreds of millions of users worldwide and an immense ocean of content-from their platforms. Yet, plaintiffs have failed to allege that defendants intentionally provided any substantial aid to the Reina attack or otherwise consciously participated in the Reina attack-much less that defendants so pervasively and systemically assisted ISIS as to render them liable for every ISIS attack. Plaintiffs accordingly have failed to state a claim under \$2333(d) (2). We therefore reverse the judgment of the Ninth Circuit."

In a related case before the court, Gonzalez v. Google, SCOTUS ordered that case be remanded to the Ninth Circuit to be considered in light of the decision in Twitter v. Taamneh.



BIG DECLARATIONS, EAGLE FEATHERS BANNED, **ENTERTAINMENT OPENINGS**

PRESIDENT BIDEN. POPE FRANCIS MAKE GOOD ANNOUNCEMENTS: GOVERNOR STITT VETOES ANOTHER ONE, STUPID

Okmulgee, Oklahoma—At the beginning of May the White House issued a proclamation observing Missing or Murdered Indigenous Persons Awareness Day. President Joe Biden said the U.S. Attorney's Office would "better prioritize" this crisis and create a new position that would be devoted to ensuring those affected would have a voice. O.K., let's see how that takes shape and addresses these tragedies. Deeds, not words.

Pope Francis has added

another step towards healing the wounds created by the historical Catholic Church. The Pope said that "talks were underway to return colonial-era artifacts in the Vatican Museum that were acquired from indigenous peoples..." Yahoo News reported, in an airborne press conference that the Pontiff himself said, "The Seventh Commandment comes to mind: If you steal something you have to give it back."

Someone who isn't a Pope, but acts like one lately, has added Governor Stitt's veto to three bills that Natives favor. He is refusing to sign a bill re-authorizing the

state Indian education office, a bill allowing for Native Students to wear tribal regalia at graduation ceremonies, and legislation requiring sex offenders to submit tribal registration.

To take this issue a step further...Broken Arrow school officials prevented a student from wearing an eagle plume, damaging the feather in the process. That will be nothing compared to the damage to the school's reputation. See ya'll in court. Myskoke Principal Chief David Hill has issued a response to the regalia part of the issue. On May 2, he said, "It's time that once and for all, we do the right thing by these students and respect their family choices. We're disappointed that the Governor is standing in the way of that with his veto."

This one happened in early April, but worth noting. The New York Board of Regents has officially banned Native names and images, says the Albany Times-Union. The idea popped up and was pushed along in 2001. There is a lot of support for the action, but one can expect the usual flurry of lawsuits.

Another sports announcer has shot his mouth off over a Native name and wish he hadn't. Zach Whitecloud is from the Sioux Valley North Dakota Nation and plays as a defenseman for the Las Vegas Golden Knights. During a game against the Edmonton Oilers, ESPN anchor John Anderson commented about Whiteclouds' name. Anderson said, "Zach Whitecloud, what kind of name is Whitecloud? Great name if you're a toilet paper." Anderson did apologize the next day, "It's my job to be prepared and know the backgrounds of the players, and I blew it..."

It's mid-May and still no decision on the Freedmen issue from our tribal courts. It's probably going to be announced right after this column is published? Maybe the U.S. Supreme Court will get off it's backside and decide the Native cases before it.

There is a shining spot in the news for Natives and especially the Ponca Tribe. In 1869, Chief Standing Bear fought a landmark legal battle in which the court ruled that Standing Bear was a "person" with the rights and protections of other citizens. In a recent action, the U.S. Postal Service has issued a new postage stamp in the Ponca Chiefs' honor. By the way, it's a "forever" stamp. Let's see if that value lasts longer than the treaties the government has signed.

More good stuff...Season 3 of "Reservation Dogs" is set for August 2 on Hulu. It's going to be interesting to see where the series goes after the story has shown loss and achievement, disappointments and fear, plus incredibly insightful humor. "Killers of the Flower Moon" will be opening October 6 in theaters. The story of the murders of Osage people for their oil rights will also stream on Apple TV later.

The 2023 Myskoke Festival is coming up at the end of June. Ready for it? Yes!

The MCN Tribal election is coming up in November. Ready for it? No.

FEDERAL ROADS **PROGRAM FULLY FUNDS COMMUNITY PROJECT**

MCN STEPPED IN TO FUND A HIGHLY TRAVELED BRIDGE IN THE COMMUNITY

Okmulgee, Okla. - The Old Morris Highway Bridge is now open after a nearly two-year closure with a ribbon cutting ceremony on May 3.

Premier Steel manufactured the fast-cast bridge that was delivered on March 15.

CrossTimbers Consulting designed the bridge. McGuire Brothers contracted the project, which was completed in less than two months once construction began.

Principal Chief David Hill is grateful for the partnerships between the Nation, county, and community for projects of this cal-

"It's all about public safety," Chief Hill siad. "We have a lot of Creek citizens and non-Creeks who live down this road and we do our best to help each other to make it better and safer for everyone to travel."

An estimated 1100 vehicles travel the road daily, according to Muscogee (Creek) Nation Federal Roads Program Manager David Ford.

"That's very busy," Ford said. "It means a lot to the community."

Okmulgee County Commissioner David Walker said the bridge had sustained significant damage in May 2021.

"The culvert's dislocation washed out and the county came in and we took 2,000 pound blocks and tried to get it back going,"

Walker said. "We thought we had it under control."

In May 2022, the area experienced a severe flood with rainfall exceeding 14 inches over a period of three days. That caused the bridge to be swept out by water once again.

All that was left of the bridge were guardrails on either side of the two-lane road with a large gap where the water flows.

The highly traveled side road remained closed for the next year.

"I believe that was the third time," Ford said. "But it was the last time."

According to Ford, the county lacked funding to properly fix the road. That's when the MCN stepped in.

"Federal Roads thought it would be a good opportunity," Ford said.

The program spends anywhere from \$10-14 million annually on roadway infrastructure within the Muscogee Reservation.

"We are glad we could help get this bridge open," Ford siad.

Ford has sent an invitation to the county commissioners within the Muscogee boundaries. This opportunity will allow them to pick a bridge in their district to be funded and completed by the pro-

gram. With more bridge funding available, Ford claims reservation residents can expect to see new bridges throughout the reservation soon.



MCN PAGEANT DATE SET **FOR JUNE 3**

THE EVENT WILL BE HOSTED AT THE CRYSTAL THEATRE

Okemah, Okla. - Contestants for the Muscogee (Creek) Nation Scholarship Pageant will compete against each other at the Crystal Theatre at 2 p.m. on Saturday, June

According to MCN Royalty Coordinator LuAnn Bear, citizens have requested the pageant to make its presence in the southern region for many years. This year's venue has the capacity to seat over 200 people. Bear is hoping to fill each of those seats.

"We are encouraging our citizens in that area to come by and visit," Bear said.

She claims there were immediate reactions of excitement for the pageant's location announcement.

The Crystal Theatre is an old movie theater that was originally built in the 1920s. It served the area for nearly a century before closing in 2020. It was recently purchased by the Thlopthlocco Tribal Town headquartered in Okemah in 2022.

Bear said it is a much different setting than what the pageant is used to. It still resembles an old movie theater.

"We are thankful to rent the space from them," Bear said.

Last year's pageant was held at

The River Spirit Casino and Resort Ballroom. Previously, the pageant has been held virtually due to the Covid pandemic. The most common site has been the Mvskoke Dome.

Contestants have undergone etiquette training, Mvskoke language classes, talent practicing, and even staging for the pageant itself during the Royalty Ready and Royalty Retreat events.

There are four contestants for the Jr. Miss Muscogee Nation title and one contestant for the Miss Muscogee Nation title.

MCN HUMAN SERVICES DEPARTMENT SET TO RECEIVE \$2.5M IN RELIEF

REPATRIATION AGREEMENT RETURNS THOUSANDS OF HUMAN REMAINS TO MCN

Okmulgee, Okla. - A Muscogee (Creek) Nation National Council Regular Session meeting was held in person and teleconference May 20 at the Mound Building.

National addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 23-043 A tribal resolution of the Muscogee (Creek) Nation confirming the nomination of Lea Ann Nix to serve on the Muscogee (Creek) Nation Citizenship Board. Representative Joyce C. Deere sponsored the legislation, which was adopted 13-1.

Nix's term will begin upon confirmation and will expire on June 1, 2028.

TR 23-044 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute a Transfer of Control NAGPRA Agreement for Ancestors and Fundery Objects from Moundville Archaeological Site with the University of Alabama. Representative Galen Cloud sponsored the bill, which was adopted unanimously 14-0.

UA has possession of 10,245 individuals of Native American ancestry, as well as 1,520 associated funerary objects excavated from the Moundville archaeological site in Hale and Tuscaloosa Counties, and Alabama. UA has determined that there is a cultural affiliation between those remains and funerary objects to the present day Muskogean-speaking Indian Tribes. MCN has entered into a joint repatriation claim for these remains with other Native American tribes.

TR 23-045 A tribal resolution of the Muscogee (Creek) Nation amending TR 19-076 (A tribal resolution of the Muscogee (Creek) Nation to suspend all special appropriations and donations) as amended by TR 20-150, TR 21-080, TR 22-128, TR 22-143, TR 22-150, TR 22-155 and TR 23-170. Representative Sandra Golden sponsored the bill, which was adopted unanimously 14-0.

TR 19-076 is amended to read as follows: a one time donation to You Can! Inc. if NCA 23-033 is enacted. This follows other special exceptions regarding special appropriations and donations if certain laws are enacted.

TR 23-046 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute a memorandum of understanding between the Muscogee (Creek) Nation, Alabama Quassarte Tribal Town, Kialegee Tribal Town, and Thlopthlocco Tribal Town for the method of allocation for the nation's proportional share of funding for housing and urban development funds and the FY -2024 Indian Housing Block Grant. Representative Charles McHenry sponsored the bill, which was adopted unanimously 14-0.

The Nation and the tribal towns agree that it is in the best interests of the Tribal Towns, the Nation, and the Creek Citizens for HUD to use enrollment for receiving their proportional share of the needs for the Indian Housing Block Grant where the Tribal Towns receive funding based on double their enrollment. The Nation will receive the remaining portion.

TR 23-047 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute a first amendment to the Memorandum of Agreement among the U.S. Army Corps of Engineers, Charleston District; Federal Railroad Administration or other U.S. Department of Transportation Agency; Palmetto Railways; Advisory Council on Historic Preservation; Muscogee (Creek) Nation; The South Carolina State Historic Preservation Officer; and the South Carolina State Ports Authority regarding the Navy Base Intermodal Facility Project in Charleston County, South Carolina. Rep. Cloud sponsored the bill, which was unanimously adopted 14-0.

The MOA was intended to mitigate any adverse effects on historic properties in the area of said proposed NBIF. Palmetto Railways failed to fully perform Stipulation II.A of said MOA, in which Palmetto Railways was to monitor adversely affected historic properties for construction vibration damage during construction and for a period of two years during operation of a Navy Base Intermodal Container Transfer Facility. Each entity will work together in a collaborative effort to preserve and protect any human remains or archaeological artifacts discovered during the construction of the NBIF Project.

TR 23-048 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute a Muscogee (Creek) Nation Department of Housing Contract with Harris Contractors. Rep. Cloud sponsored the bill, which was unanimously adopted 14-0.

The bill will allot for Harris Construction to construct one home for the department of housing. The total cost of the

home will be \$298,617.00. TR 23-050 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute a Purchase Sale Agreement for property located in Hughes County, Oklahoma. Representative Anna Marshall sponsored the bill, which was unanimously adopted 14-0.

The property and its facilities will be used to benefit the Holdenville Indian Community for a new smoke shop and additional office space.

TR 23-051 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to submit a grant application to the Internal Revenue Service for the benefit of the Office of the Secretary of the Nation. Representative Mark Randolph sponsored the bill, which was unanimously adopted 14-0.

The bill states that the Nation is in need of providing assistance in preparing income tax returns for individuals who are 59 and younger and that the Nation meets the eligibility requirements for the Volunteer Income Tax Assistance (VITA) program. The nation will leverage \$15,000 in resources for the

NCA 23-030 A law of the Muscogee (Creek) Nation establishing a new law in the Title 35, Chapter 13, subchapter 2, entitled "Tribal Grave House Assistance Program". Representative Thomasene Yahola Osborn sponsored the bill, which was unanimously adopted 14-0.

The purpose of this bill is to provide a family of the deceased up to five hundred dollars to be used toward the purchase of supplies to construct a grave house. The overall authorized annual budget of \$250,000 will be used for the program and will be funded by the Comprehensive Annual Budget beginning Fiscal Year 2024.

NCA 23-031 A law of the Muscogee (Creek) Nation amending MCNCA Title 35, Chapter 6 entitled "School Clothing Program". Representative Robert Hufft sponsored the bill, which was unanimously adopted 14-0.

The School Clothing Program will need additional funding to reflect the increased amounts beginning Fiscal Year 2024. The increased budget will reflect the changes accordingly.

NCA 23-033 A law of the Muscogee (Creek) Nation authorizing a donation to You Can! Inc. for the Okemah Summer Kids Cafe. The bill was sponsored by Rep. Golden and cosponsored by Representative Randall Hicks. It was adopted unanimously 14-0.

You Can! Inc. is a nonprofit organization that oversees the Okemah Summer Kids Cafe, which is a free two month summer feeding and activities program open to all kids ages 1-18. The cafe serves 300 children, of which fifty percent identify as Muscogee (Creek) Citizens. MCN will provide a donation totaling \$2,000.

NCA 23-034 A law of the Muscogee (Creek) Nation authorizing a budget modification in excess of ten percent (10%) for the Muscogee (Creek) Nation Realty/Trust Department FY 2023 budget. Rep. McHenry sponsored the bill, which was unanimously adopted 14-0.

The Realty/Trust Department is making this budget modification request to reallocate certain funds for other necessary expenses as outlined in the attached budget modification request.

NCA 23-035 A law of the Muscogee (Creek) Nation amending NCA 23-013 (A law of the Muscogee (Creek) Nation authorizing a supplemental appropriation for the Muscogee (Creek) Nation Risk Management - Arbor Care Services Fiscal Year 2023). Rep. Cloud sponsored the bill, which was unanimously adopted 14-0.

The amount of \$748,445 will be appropriated from the Gaming Fund Account.

NCA 23-039 A law of the Muscogee (Creek) Nation appropriating funds to be used toward the purchase of property located in Hughes County, Oklahoma. Rep. Marshall sponsored the bill, which was unanimously adopted 14-0.

The funding source was identified as Economic Development and Land Acquisition, and a total appropriation of \$32,000 will be used for the associated costs of the property including title insurance, title opinions, surveys, environmental studies and applica-


NCA 23-040 A law of the Muscogee (Creek) Nation authorizing a supplemental appropriation to the tribal workforce vocational training program to be administered by the Muscogee (Creek) Nation employment and training for Fiscal Year 2023. Rep. Deere sponsored the bill, which was unanimously adopted 14-0.

According to the bill, a supplemental appropriation is needed for the Adult Work Experience program for administrative costs, client services, personnel-eta and support services. An appropriation in the amount of \$340,125 will be used toward the program.

NCA 23-042 A law of the Muscogee (Creek) Nation authorizing the expenditure of fiscal relief funding for the benefit of the Muscogee (Creek) Nation Community and Human Services Department. Rep. Hufft sponsored the bill, which was adopted 13-1.

The MCN National Council will expend \$2,500,000 in federal funds from the American Rescue Plan Act. The funds will be used to provide assistance to households or populations facing negative economic impacts due to COVID-19 including food, rent, mortgage and utility assistance.

All passed legislation will go before the full Council during the regular session.

HEW/LNC and BFJ/HEW addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 23-050 Authorizing the Principal Chief to execute a purchase sale agreement for property located in Hughes County, Okla. Representative Anna Marshall sponsored the legislation, which passed 7-0.

The property and its facilities will be used to benefit the Holdenville Indian Community for a new smoke shop and additional office space.

TR 23-051 Authorizing the Principal Chief to submit a grant application to the Internal Revenue Service for the benefit of the Office of the Secretary of the Nation. Representative Mark Randolph sponsored the legislation, which passed 7-0.

The Nation seeks to submit the grant application for \$15,000. The Council will match another \$15,000 for the VITA program.

TR 23-052 Authorizing the Principal Chief to execute a purchase sale agreement for property located in Muskogee County, Okla. Representative Mary Crawford sponsored the legislation, it was cosponsored by Joyce Deere, which was postponed until June 16.

The property and its facilities will be used for the benefit of the Muscogee (Creek) Nation Department of Health for the renovation of a hospital facility currently present on the land for the purposes of an in-patient addiction recovery facility.

NCA 23-039 Appropriating funds to be used toward the purchase of property located in Hughes County, Okla. Representative Anna Marshall sponsored the legislation, which passed 7-0.

The funds of \$32,000 will be appropriated for TR 23-050.

RESOLUTION URGES OK LEGISLATURE TO OVERRIDE GOVERNOR'S VETOES

OKLAHOMA HB 2608 AND SB 429 WERE RECENTLY VETOED BY GOV. STITT

Okmulgee, Okla. - The Muscogee (Creek) Nation National Council held an Emergency session via teleconference on May 11.

The Council addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 23-053 Respectfully urging the Oklahoma State Legislature to override the vetoes of Oklahoma House Bill 2608 and Senate Bill 429. Representative Mark Randolph sponsored the legislation, which was adopted 12-0.

HB 2608 would require sex offenders registered with tribal authority to also register with the state. SB 429 would allow Native American students enrolled in a public school district, public charter or technology center to wear tribal regalia at their respective graduation ceremony.

The MCN believes the

house bill veto should be overridden to share sex-offender information between state and tribal agencies for

public safety reasons.

According to the bill, the MCN fully supports Native American students' right to wear tribal regalia at a public school district, a public charter school, or a technology center graduation.

NCA 23-041 Authorizing the expenditure of American Rescue Plan Act funds received from the United States Department of the Treasury for the Fiscal Relief Funding for the Mvskoke Loan Fund. Rep. Randolph sponsored the legislation, which was adopted 13-0.

The Myskoke Loan Fund will utilize \$757,961 in funds to offset negative economic impacts the COVID-19 pandemic has had on small busi-

NCA 23-042 Authorizing expenditure of Fiscal Relief Funding for the benefit of the MCN Community and Human Services Department. Representative Robert

Hufft sponsored the legislation, which was postponed until the May 20 Regular Session 13-0.

The funds will provide 2,500 Muscogee children with special needs with a one-time assistance of \$1,000. According to the bill, this is due to the fact that their households have been disproportionately impacted by the pandemic. The total amount of funds expended from this bill is \$2,500,000.

NCA 23-043 Authorizing the expenditure of Fiscal Relief Funding for the benefit of the Muscogee (Creek) Nation Education Department. Representative Leonard Gouge sponsored the legislation, which was adopted

The funds will provide up to 5,000 Muscogee students and scholars who did not previously receive COVID-19 related assistance for technology assistance in the amount of \$850 for technology assistance. The total amount of funds expended from this bill is \$4,305,000.

NCA 23-044 Authorizing the expenditure of American Rescue Plan Act funds received from the United States Department of the Treasury for the Fiscal Relief Finding for the Homeless Veterans Reintegration Program (HVRP) Project. Representative Joseph Hicks sponsored the legislation, it was co-sponsored by Representative Galen Cloud and Rep. Gouge. The legislation was adopted 13-0.

Funding will help continue services through training, job centers, and veteran entities. The total amount of funds expended from this bill is \$464,961.

Okmulgee, Okla. - The Muscogee (Creek) Nation National Council held the monthly Land, Natural Resources, and Cultural Preservation Committee session at the Mound Building on May 9.

Passed legislation is subject to Full Council approval during the Regular Session held the last Saturday of each month.

The committee addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 23-044 Authorizing the Principal Chief to execute a Transfer of Control NAGPRA Agreement for Ancestors and Funerary objects from the Moundville Archaeological Site with the University of Alabama. Representative Galen Cloud sponsored the legislation, which passed 4-0.

The University will transfer the control of 10,245 individuals and 1,520 associated funerary objects to the MCN and six other tribes, pursuant to the joint repatriation claim made on June 11, 2021 with the Alabama Quassarte, Coushatta Tribe of Louisiana, Seminole Tribe of Florida, Chickasaw Nation, Choctaw Nation, and Seminole Nation.

TR 23-046 Authorizing the Principal Chief to execute a Memorandum of Understanding between the Muscogee (Creek) Nation, Alabama Quassarte Tribal Town, Kialegee Tribal Town and Thlopthlocco Tribal Town for the Method of Allocation for the Nation's Proportional Share of funding for Housing and Urban Development funds and FY 2024 Indian Housing Block Grant. Representative Charles McHenry sponsored the legislation, which passed 4-0.

Service areas are overlapping for determining the needs portion of the Indian Housing Block Grant Formula. HUD communicated that if the Nations and Tribal Towns can't agree on a method of allocation, the HUD will choose for them.

The Nation and tribal towns agree it is in their best interests for HUD to use enrollment for receiving their proportional share of needs for the grant.

TR 23-047 Authorizing the Principal Chief to execute a First Amendment to the Memorandum of Agreement among the U.S Army Corps of Engineers, Charleston District; Federal Railroad Administration or other U.S. Department of Transportation Agency; Palmetto Railways; Advisory Council on Historic Preservation; Muscogee (Creek) Nation; the South Carolina State Historic Preservation Officer; and the South Carolina State Ports Authority regarding the Navy Base Intermodal Facility Project in Charleston County, South Carolina. Rep. Cloud sponsored the legislation, which passed 4-0.

The MOA is intended to help mitigate any adverse effects on historic properties in the area. The South Carolina State Ports Authority is taking over ownership of the Navy Base Intermodal Facility Project.

The committee addressed the following legislation, the interpretation of which is attributed to language in the bills:

NCA 23-036 Amending MCNCA Title 14, Subchapter 3, entitled "Extradition of defendant subject to other jurisdiction". Representative Randall Hicks sponsored the legislation, which was unanimously postponed until the

next BFJ meeting 4-0.

The subchapter, now titled "Extradition" was rewritten to give clear guidelines to follow for defendants facing this issue.

NCA 23-037 Creating New Law in Title 37, Chapter 10 entitled "Departmental Policies and Procedures." Representative Sandra Golden sponsored the legislation, which failed to pass 2-3.

The proposed law would have created requirements for MCN departments' policy and procedures. This would have involved turning hard copies in the workplace subject to National Council approval.

RYJAN REININGER




