STATE LEGISLATURE OVERRIDES STITT'S VETOES

AFTER THE GOVERNOR TRIED TO SQUASH STUDENTS' RIGHT TO WEAR REGALIA, OK LEG. OVERRIDES VETO

OKLAHOMA CITY, Okla. -Senate Bill 429 was overridden in a vote of 80 yays, 11 nays and ten excused by the Oklahoma State Legislature on May 25. Students who choose to wear tribal regalia at graduation ceremonies are now protected by the law.

The bill was vetoed by Oklahoma Governor Kevin Stitt on May 1, just as students were building excitement for educational accomplishments.

Introduced to the Senate in February, the bill passed through with 45 yays and zero nays. In the House of Representatives the bill flew through 90 yays and one nay.

The bill was sent to the Governor on April 25 and was vetoed within six days.

In his veto message Stitt claimed the "proverbial Pandora's Box" would open, encouraging other groups to "wear what they please" during ceremonies.

The legislature also overrode his veto of SB 299 with overwhelming support with 83 yays, 12 nays, and six excused.

The bill extends the Oklahoma Advisory Council on Indian Education until 2026.

The measure modifies the appointing authority for membership by allowing the Speaker of the House of Representatives to

appoint 5 members, and the President Pro Tempore of the Senate to appoint 4 members.

It provides that a vacancy on the Council in a seat representing an Indian tribe or the tribal education department of an Indian tribe may be filled by the original appointing authority from a list of nominations submitted by the elected executive leaders of Indian tribes in the state.

Muscogee Nation Principal Chief David Hill released a statement on social media and said, "These bills are now law and we thank our legislators for doing the right thing and advancing measures that should not be considered controversial or used as political maneuvering."

The Muscogee Nation National Council adopted a resolution urging legislators to override the vetoes during an Emergency Session early May.

The bills were just a couple included in the long list of vetoes legislators are referring to as the "tantrum 20" from Stitt.

Stitt released a statement after vetoing 20 plus bills:

"Oklahomans elected me to advocate on their behalf and fight for the taxpayer," Stitt said in the statement. "I take this responsibility seriously. So, I cannot, in good faith, allow another year to go by without cutting taxes and reforming education, both of which we can absolutely afford with our \$1.2 billion surplus and over \$6 billion in savings.

"Therefore, until the people of Oklahoma have a tax cut, until every teacher in the state gets the pay raise they deserve until parents get a tax credit to send their child to the school of their choice, I am vetoing this unrelated policy and will continue to veto any and all legislation authored by Senators who have not stood with the people of Oklahoma and supported this plan."

OKMULGEE COUNTY EXPERIENCES OVERNIGHT CRIME WAVE

OFFICER SHOT IN OKMULGEE WHILE A WOMAN WAS KIDNAPPED IN DEWAR by MORGAN TAYLOR

MVSKOKE RESERVATION, Okla. - Late Wednesday night on May 31 Dewar residents witnessed a man drag a woman from her house to a silver Jeep while beating her, then speeding off.

The car was driven by Cameron Gooden, and was hauling at high speeds with the owner, Trudi Blades inside. Gooden is a Muscogee (Creek) citizen.

Blades' adult son and his pregnant girlfriend were left at Blade's home. They were also assaulted by Gooden just before fleeing with Blades.

The pregnant woman was released from the hospital with no serious injuries.

Gooden took a right by the Dewar First Baptist Church, leading him to Holly Road. The road was also the site where seven dead bodies were found just last month in Henryetta.

Dewar police responded to a call on Gooden and began pursuing the vehicle, but lost sight of it as it turned on Arbeka Road.

Dewar police fell back and reported the case to the Muscogee (Creek) Nation Lighthorse Police Department. They proceeded to actively search for the couple with no luck.

Gooden's cell phone was pinged at a location near Ryal School on John Artussee Road in southern Henryetta.

The location was searched with no sign of Blades, Gooden, or the vehicle.

Law enforcement stopped actively pursuing the two when an officer was shot in Okmulgee.

Officer shot in Okmulgee

During the search for Blades, Okmuglee police responded to an active burglary call at 1:45 a.m. on June 1 near Second and Central in Okmulgee.

The burglary was a home invasion. The owners were forced out of the home, but were able to contact the police.

The Oklahoma State Bureau

of Investigation said one officer went to the front of the house and a second officer went to the back. The second officer was shot by the suspect, Christopher Harris.

Assistance was called where multiple agencies, including the MCN LPD responded.

The injured officer was taken to the hospital in stable condition, and was released at 9:40 a.m.

Harris' last known location was around Second and Central in Okmulgee around 3:00 a.m.

The area was blocked off by law enforcement for some time as they secured the neighborhood and ensured public safety.

Harris is considered a fugitive, and is armed and dangerous.

Recently released from prison, Harris is well-known to agencies across the state and in other states as well.

The search for Blades

According to social media posts, law enforcement completely withdrew from the search for Blades after the Okmulgee County officer shooting.

Law enforcement's last clue as to Gooden's wearabouts was his cell phone location. It was pinged at Ryal. Concerned friends said the area is a "dead area" for cell phone service and that Blades "could be anywhere".

Reportedly after trying to hide in his old hangout spot near Ryal, Gooden headed east to the Tiger Mountain Area where he ditched the Jeep he kidnapped Blades in.

For most of the night of May 31 Gooden and Blades walked the mountain, a country area filled with dirt roads, woods, small rivers and creeks.

As they were walking, an unknown passerby stopped to ask them if they needed a ride. That is when they returned to Blades' house. When they got inside, Gooden still held Blades hostage.

According to Blades' niece, Blades convinced Gooden to let her go by telling the police that everything was alright, and that she was not in danger.

Finally at about 10:30 a.m on June 1, Blades' family was contacted by the Dewar Police Department, where they stated that they had Blades and that she was safe.

According to Blades' niece, Gooden was threatening Blades with a knife. This kept her frightened.

MCN PD caught Gooden at Blades' residence. He is now currently in custody.

If anyone has information on the whereabouts of Harris, they are encouraged to call 911.



MVSKOKE FUND HITS BIG MILESTONE THE DEPARTMENT CELEBRATED IT'S TEN YEAR ANNIVERSARY

OKMULGEE, Okla. - The Mvskoke Fund celebrated a decade of providing business lending services to tribal citizens on the Mvskoke Reservation.

In 2013 the National Council enacted legislation to get the Mvskoke Fund operating with offices located in the Housing Building.

According to CEO Robby

Deere, the department had a portfolio containing 40 clients when he joined the program five years ago.

Since then the Mvskoke Fund has grown to serve over 1,100 clients. Eventually they even moved into their own building at 1523 S Wood Dr. in Okmulgee.

"We want to mark the milestone, celebrate how far we've come and how much we've grown but also we're out here still trying

to push growth," Deere said.

Business Development Officer Eric Starr joined shortly after Deere.

In the five years on the job, the two claim they have witnessed economic development across the reservation with Native-owned businesses.

"Business development and self-sufficiency wasn't really pushed out there," Starr said. "Back in 2018, we started trying

"Our bread and butter is \$50,000 and under," Deere said. "But if somebody's got a good proposition we'd love to hear it."

Within the last two years, the department has included agribusiness lending as another way to boost Native American's economic self-sufficiency.

"We want to go back to the table to people we told no in the past and let them know that this is a product we do offer now," Deere said.

The department is kicking off the second series of the Agribusiness Training with locations across the reservation.

Participants must live within the reservation and be a part of a federally recognized tribe. Muscogee citizens must reside within the state of Oklahoma.

MVSKOKE LIGHTHORSE POLICE DISCOVER STOLEN PROPERTY IN HOTEL

AN ARREST FOR THE VIOLATION OF A PROTECTIVE ORDER LED LPD TO A MUCH LARGER CRIME

OKMULGEE, Okla. - The Muscogee (Creek) Nation Lighthorse Police were led to an interesting discovery after suspect Kyle Acton was jailed and released for a protective order violation.

It was the evening of May 26 when LPD received a call about a possible protective order violation.

While on the way home, an officer located the suspect carrying an airsoft pistol, a knife, and a jar of change.

None of these items were illegal, so LPD gave the objects to Acton's girlfriend. They then took him in on the active warrant.

It was concluded from the protective order investigation that Acton was living in the wood line by his girlfriend's grandmother's house to "keep an eye" on everybody.

Acton, his girlfriend, and his girlfriend's grandmother are all Native Americans. The protective order against Acton is from his girlfriend's grandmother.

The next morning on May 27 LPD received a call about a possible burglary.

The residence was located about a block away from the home where Acton's girlfriend lives with her grandmother.

Responding to the burglary, LPD took a detailed report on the incident which included the missing items such as sports memohis jail paperwork from the previous day.

Acton's girlfriend's brother was alarmed by the property she had with her, the items Acton was arrested with.

The brother reached out to LPD, concerned that there may have been items involved in the burglary just up the block. LPD then picked up the items and took them back to the burglary victim. The victim identified the stolen items as his.

Linking him to the scene, LPD located Acton at a hotel in Okmulgee. LPD filed for a search warrant of the room, where the items were discovered upon entry.

In the room were five NFL jerseys, rare coins, and jewelry among other items.

"To top it all off, in the bag of stolen stuff was our suspect's jail ID from Friday night," Light horse Corporal Brent Colbert said.

Other items were discovered at the property of St. Anthony's Catholic Church in Okmulgee, which is near the tree line where Acton was staying.

LPD was able to give back the burglary victim all the items they were missing.

"At the end of the day, we're glad to give all that back," Colbert said. "Citizens can sleep safely at night knowing he's off the streets."

Acton was arrested and is being held in Okfuskee County jail for burglary charges.

MCN EMERGENCY MANAGEMENT HAS **OVERSIGHT OF WATER PROJECTS**

A TOTAL OF \$20 MILLION WILL BE USED FOR WATER RESTORATION

OKMULGEE, Okla. - The Muscogee (Creek) Nation, the State of Oklahoma, and Indian Health Service have matched funds for 14 projects in nine communities across the reservation. The expected amount of funding to be used is about \$20 million.

According to MCN Director of Emergency Management Bobby Howard, the tribe's contribution is over \$6 million.

The MCN National Council passed TR 23-029, which committed to matching funds in collaboration with the state of Oklahoma for the American Rescue Plan Act Tribal Cooperation Grant Program. It allocated \$57 million of ARPA funds to match tribal funds to advance collaborative water infrastructure projects.

MCN identified projects that are crucial to public health and economic growth, matching \$6,750,000 to the projects.

Howard claims that each project is flowing directly through his office.

He also claims most of the systems are currently out of date.

"The systems we are going to rehab, repair or completely rebuild and replace date back to the 70's and

80's," Howard said.

Howard used the City of Beggs as an example.

Beggs residents have had issues with the municipal water for years. Multiple complaints have been made by residents in many forms including public city meetings and on Facebook forums.


According to these complaints, the water pressure in the community runs low and even results in a no-water situation for the water users.

Howard claims his department had taken water buffalo trailers to the community more than eight times during the last year. This was due to the city's recurring water issue from the previous administration.

Howard said in a water system, there is a part called a "clear well" that is an important piece to the water distribution. Somehow the previous administration completely bypassed the clear well, which was pulling water directly from Beggs Lake. This resulted in low pressure when several homes were using the water.

The restoration project is just one of the 14 taking place across the reservation, with projects in Porter, Dewar, Inola, and Wetumka, among others.

Since many of the communi-

ties on the Mvskoke Reservation are small and rural, Howard claims there is no way some of the communities could afford to update their water systems.

Citizens around the reservation can expect these water restoration projects within the next couple years. Howard claims it should not affect water usage.

This is a developing story.

SELF-GOVERNANCE COMPACTS UPDATED FOR FY 2022 AND 2023

LEGISLATION ON NEW MCN DEPARTMENT OF HUMANITIES ON HOLD

OKMULGEE, Okla. - A Muscogee (Creek) Nation National Council Emergency Session was held via teleconference June 1.

The Council addressed the following legislation, the interpretation of which is attributed to language in the bills:

TR 23-055 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute an assignment and assumption of purchase and sale agreement and approving certain provisions within the purchase and sale agreement for property located in Wagoner County, Oklahoma. Representative Randall Hicks sponsored the bill, which was adopted unanimously 14-0.

The property is composed of 36.5 acres and will be used by gaming operations to enhance its commercial activities.

TR 23-056 A tribal resolution of the Muscogee (Creek)

Nation authorizing Muscogee Nation Gaming Enterprises, LLC ("MNGE") to execute the design-build agreement between River Spirit Casino Resort and I-5 Design-Build, Inc. Rep. Randall Hicks sponsored the bill, which was unanimously adopted 14-0.

The agreement will allow I-5 Design-Build Inc. to provide labor and furnish certain materials associated with the renovation of the existing buffet to create a new Sports Bar, VIP Bar, Lounge, and Ballroom at the River Spirit Casino Resort. The total cost of the project is \$13,594,316.

TR 23-057 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute an updated compact of self-governance and a multiyear funding agreement between the Muscogee (Creek) Nation and the Secretary of the Interior. Speaker William Lowe sponsored the bill, which was unanimously adopted 14-0.

The compact will allow the Nation to redesign programs, services, functions and activities, reallocate funds, prioritize said PSFAs, enhance the effectiveness and long-term financial stability of its tribal government and include detentions and corrections services as part of its criminal jurisdiction and justice services. This will retain the multi year funding for fiscal year 2023.

TR 23-058 A tribal resolution of the Muscogee (Creek) Nation authorizing the Principal Chief to execute an updated compact of self-governance and a multiyear funding agreement between the Muscogee (Creek) Nation and the Secretary of the Interior. Speaker Lowe sponsored the bill, which was unanimously adopted 14-0.

The compact will allow the Nation to redesign programs, services, functions and activities, reallocate funds, prioritize said PSFAs, enhance the effectiveness and long-term financial stability of its tribal government and include detentions and corrections services as part of its criminal jurisdiction and justice services. This will retain the multi year funding for fiscal year 2022.

NCA 23-045 A law of the Muscogee (Creek) Nation amending MCNCA Title 16, Chapter 1 § 1-102 entitled "the organization for the executive office of the Principal Chief" to organize various cultural and humanities programs by creating a new cultural and humanities department. Representative Galen Cloud sponsored the bill. It was co-sponsored by Representative Leonard Gouge, and Representative Joseph Hicks. It was unanimously decided that the bill would be postponed until the next HEW/ LNC Joint Committee Meeting, 14-0.

According to language in the bill, the purpose of the act is to "organize various cultural and humanities programs throughout the Department of Culture and Humanities." If adopted, it will allow for more oversight and administration of the various cultural resource programs.

NCA 23-046 A law of the Muscogee (Creek) Nation establishing a new Title 16, Chapter 4 entitled "Culture and Humanities Department" and appropriating funds. Rep. Cloud sponsored the bill. It was co-sponsored by Rep. Gouge and Rep. Joseph Hicks. It was unanimously decided that the bill would be postponed until the next LNC Committee Meeting, 14-0.

The new law would codify new language to be used in future bills moving forward regarding the new department. It would also define jurisdiction, power and authority, qualifications for members of the department, establish expectations and responsibilities, list areas of interest, and continue to preserve culture, oral tradition, history, research, and tribal law. The total cost of the appropriation will be \$273,148.

NCA 23-047 A law of the Muscogee (Creek) Nation appropriating funds to create the Mvskoke Language Liaison Program. The bill was sponsored by Rep. Cloud, and was co-sponsored by Rep. Gouge and Rep. Joseph Hicks. It was unanimously decided that the bill would be postponed until the next LNC Committee Meeting, 14-0.

The program would be composed of multi-generational staff responsible for serving as liaisons between Mvskoke speakers and academic, cultural, and tribal institutions in an effort to perpetuate the Mvskoke language. They will collect and manage data on the Mvskoke language and organize efforts to develop more robust communities. The total cost of the staff would be \$325,627.

NCA 23-055 A law of the Muscogee (Creek) Nation authorizing a supplemental appropriation to the department of higher education emergency scholarship program's Fiscal Year 2023 budget. Speaker Lowe sponsored the bill, which was adopted unanimously 14-0.

The bill will appropriate \$75,000 to increase the Direct Assistance line item for the Emergency Scholarship Program fiscal year 2023 budget.

NCA 23-056 A law of the Muscogee (Creek) Nation amending MCNCA Title 35, Chapter 6, entitled "School Clothing Program". Representative Robert Hufft sponsored the bill, which was unanimously adopted 14-0.

The bill will appropriate \$723,000 to the MCN School Clothing Program.

NCA 23-057 A law of the Muscogee (Creek) Nation authorizing the expenditure of the American Rescue Plan Act (ARPA) Fiscal Year Recovery Funds to purchase vehicles for the benefit of the Fleet Management Department. Rep. Cloud sponsored the bill, which was unanimously adopted 14-0.

The bill will expend \$1,332,315.49 for the benefit of the Fleet Management Department.

NCA 23-058 A law of the Muscogee (Creek) Nation authorizing the expenditure of the American Rescue Plan Act (ARPA) Fiscal Year recovery funds to purchase vehicles for the benefit of the Fleet Management Department. Rep. Cloud sponsored the bill, which was unanimously adopted 14-0.

The bill will expend \$292,555.43 for the benefit of the Fleet Management Department.

The collaborating departments included the Homeless Veterans Reintegration Program, the Muscogee (Creek) Nation Department of Employment and Training, the Reintegration Program and Muscogee Nation Business Enterprise and Transit.

MCN Transit provided transportation from the Tulsa and Muskogee areas for those interested in attending the event.

MNBE assisted participants with resume building.

Organizations like Walmart, Home Depot, Paccar Winch, Bama Pie, Central Technology Center, and Green Country Technology Center were featured at the fair. College of Muscogee Nation, and other

MCN Departments and businesses brought information as well, and some even hosted on-site interviews.

According to the MCN Homeless Veterans Reintegration Program Coordinator Tacia Berryhill, employment is one of the greatest needs amongst her clients along with transportation.

Being a veteran herself, Berryhill understands the struggle of many veterans getting back out into the workfield.

"Being a veteran, you don't want anybody to know you're falling on hard times," Berryhill said. "You're supposed to endure what you need to do and figure it out on your own."

HVRP Case Manager Kaylea Berry said that getting veterans in a financially stable situation and to be able to sustain that is the goal.

Also a veteran, Berry agrees that it helps to make that connection to those in need who do not want to ask for help.

"It helps to bring that camaraderie," Berry said.

MCN Employment and

50 plus citizens weekly with proper job placement and preparation.

According to Thomas, events like job fairs can expedite the process by bringing all components under one roof.

MCN Reintegration Outreach Specialist Mark Harjo said the direct contact does help in speeding up the process.

Many of the Reintegration Program clients are coming out of incarceration, and deal with employment obstacles like criminal background histories. With the fiber optic training course, many have been able to find employment security.

Unemployment rates are currently considered to be in a stable condition according to the Oklahoma Employment Security Commission.

The commission reported the number of initial unemployment claims totaled 1,426 on May 13. This was a decrease of 71 claims from the previous week's total of 1,497. Continued claims totaled 10,104, a decrease of 109 from the previous week's total of 10,213.

NAJA to vote on Indigenous Journalists Association name change during 2023 election

The Native American Journalists Association will vote to change the name and elect

The organization was established in 1983 when Native American and First Nations journalists met to form the Native American Press Association. In 1990, the group changed to the Native American Journalists Association to lift Indigenous voices across all media platforms, and work to ensure accurate and contextual reporting about Indigenous peoples. In 2023, NAJA will celebrate its 40th anniversary and continues to develop and deliver resources, education and training for journalists covering Indigenous communities across the globe.

NAJA is calling for candidate declarations to serve on the board of directors through June 29. There are three vacancies for 3-year terms, starting in August 2023 and running through 2026.

For online voting, eligible NAJA members will receive a unique link in the email associated with their membership. Members may only cast one vote (either online or in-person) and all votes will be verified so there are no duplicates.

In-person voting will take place on Thursday, Aug. 10, from 5-8 p.m., CST at the Delta Hotel Winnipeg during the NAJA Opening Night Reception in coordination with the 2023 National Native Media Conference Aug. 10-12 in downtown Winnipeg.

Election results will be

Board members are required to attend monthly meetings and serve on designated committees. Meeting times are determined by the board on a month-to-month basis but usually occur the first Thursday of the month. If an elected member misses more than three meetings due to unexcused absences, they may be removed from office.

Board members are required to seek and secure funding for the organization. Fundraising supports membership and a pipeline of Indigenous talent into media careers, including the Native American Journalism Fellowship and the next generation of storytellers.

Candidates must be verified NAJA members in good standing in order to be eligible to run for any position within the board. Associate members are not eligible for board candidacy. Read more about nominations and board elections in Article VII of the NAJA bylaws.

After the NAJA Election Committee has determined eligibility, candidates are required to submit a biography, photo, resumé, and outline how they will address membership needs and meet fundraising goals (no more than 500 words) to the election committee.

OKMULGEE, Okla. -The Muscogee (Creek) Nation Spring Celebration has returned to an in-person event for the first time in four years with an unexpected turnout at the Claude Cox Omniplex on May 23.

The event is hosted by the Mvskoke Tribal Child and Youth Coalition, which includes several departments such as MCN Behavioral Health, Tribal TANF Youth Services, and other agencies.

The TCYC's mission is to keep families together, provide a stable and safe environment, and promote family bonding.

According to MCN Behavioral Health Project Director for Native Connections Grant Coordinator Tyler Stone, he was happy with the unexpected turnout.

MCN Behavioral Health and Event Coordinator Jasmine Jack claimed that participation had reached half of the projected number of 1,000 in just 30 minutes.

Participants were provided a resource fair, free haircuts, 3-on-3 basketball, face painting, inflatables, door prizes and cultural activities like basket weaving, small pottery, corn husk doll making lessons, stick ball demonstration and lunch.

They incorporated activities for every age group to be able to join in on the fun.

There were physical activities for the children to do whether it was jumping on the inflatables, playing stickball, jamming out to the music that the disc jockey played or playing with their friends.

Numerous resource booths included information about programs and some offered tips for emotional well being.

Local vendors with departments from the Muscogee Nation included the MCN Center for Victim Services, Department of Health, College of the Muscogee Nation, Reintegration Program, Food Distribution, Mvskoke Language Program, Tobacco Prevention, Youth Services, TANF, Tax Commission, and many more. Some were even non-Muscogee to help broaden the services.

"Whenever we reach out

to different vendors, we want to make sure that there are resources that kind of tackle that entire lifespan," Stone said

McIntosh District Representative Galen Cloud was asked to emcee the event.

"I am overwhelmed with all the kids that we have," Cloud said about the turnout.

For Cloud, seeing the kids participate in the different cultural activities is of high importance.

"For them to be out here, to take away something that's Mvskoke, that's very important to me," Cloud said.

Stone mentioned that they wanted to bring in the Mvskoke cultural aspect to give citizens that "spiritual connection."

"The culture is the protective factor," Stone said.

Stone stated that these different dimensions of health tying together with all of the different events that were provided was what they were wanting to provide the citizens.

BAD PRESS PREMIERES INTERNATIONALLY

ANGEL ELLIS SPEAKS ON THE DEBUT OF BAD PRESS IN POLAND

POLAND – After several months of traveling film festival circuits across the United States, the film "Bad Press" recently made it's international debut in May. It was featured in the Millennium Docs Against Gravity Film Festival in Poland, and was seen in Warsaw, Wroclaw, and Poznan.

The film "Bad Press" premiered at the 2023 Sundance Film Festival and won the Special Jury Award for Freedom of Expression. This film was co-directed by Joe Peeler and Mvskoke citizen Rebecca Landsberry-Baker. It featured Mvskoke Media Director Angel Ellis as a reporter battling for freedom of the press and tribal government transparency.

"Bad Press" is a documentary that displays the significant effects of the Muscogee Nation's election season after the MCN National Council repealed the media free press law. The film follows a Mvskoke Media reporter, Angel Ellis as a reporter battling for freedom of the press and transparency. It documents the outreach and advocacy for press freedoms that Muscogee (Creek) citizens ultimately voted in favor of.

Ellis was invited by the documentary team to attend the film's question and answer panels that were held after each screening. Ellis felt this exposed her to the world-wide issue of press freedom.

"It really was kind of an eye-opening situation," Ellis said. "What happened in the tribal nation for the Muscogee (Creek) Nation with censorship and freedom of the press has become a world issue."

The film festival organizers chose Bad Press for the issue of people not getting the information they want. A lot of people in Poland are fighting for rights, and are advocating for press freedom under a state-run media.

"One of the big questions I was asked on the road," Ellis said. "How do you overcome that?"

Ellis feels that this advocacy and journalism has to be people centric.

"It has to be people-driven," Ellis said. " It has to come from the most grassroots effort."

Ellis and other reporters produce these stories for the people. Ellis believes the news should work for you. The news organization should go out and answer these questions for the citizens, so people can get involved in proper civic responsibilities. Ellis wants to report on all issues for the people and future generations.

"If you address it head on we're really solving the problem," Ellis said. "If we sweep it under the rug we're just leaving that problem for the next generation to figure out."

Ellis said this film is a valuable blueprint for other communities to rally around local news. The freedom of telling these stories has backed up Indigenous peoples' image for years. This motivates Ellis to tell these stories and provide the context for citizens.

"We know as Indigenous people how powerful storytelling is, it's really the only way we have survived," Ellis said.

The deadCenter Film Festival will be premiering "Bad Press" from June 8 to June 11 in Oklahoma City.

ONGOING LEGAL COVERAGE UPDATES

COUNCIL REP. CHARGES, FREEDMAN CASE, STATE INCOME TAX CHALLENGE AND BACONE MONITORED

MVSKOKE RESERVA-TION, Okla. - Mvskoke Media has several longterm stories we are monitoring. Here is an update on the ongoing coverage.

Muscogee (Creek) Nation District Court

Former MCN National Council Representative Travis Scott has a pre-trial conference hearing scheduled for Aug 1. Scott was charged with Felony False Swearing and four misdemeanor charges of Conflict of Interest by Tribal Officials on Feb. 11, 2022. These charges were filed in relation to Scott's impeachment, which was found unconstitutional by the MCN Supreme Court.

MCN National Council Representative Joseph Hicks is scheduled to appear in court on July 7 for his second

misdemeanor DUI charge, filed on Feb 14.

The trial for Rhonda Grayson and Jeffery Kennedy's suit against the MCN Citizenship Board concluded April 4, 2023. It has been close to two months and no decision has been delivered.

Oklahoma Supreme Court

Muscogee (Creek) citizen Alicia Stroble was handed a win last year when an administrative law judge for the Oklahoma Tax Commission ruled that she was exempt from paying state income taxes. Stroble is a tribal citizen that worked for the MCN government and resided in the reservation boundaries.

The Oklahoma Administrative Code delineates the following;

"Instances in which income is exempt. The income of an enrolled member of a federally recognized Indian tribe shall be exempt from Oklahoma individual income tax when:

(1) The member is living within "Indian Country" under the jurisdiction of the tribe to which the member belongs; and, the income is earned from sources within "Indian Country" under the jurisdiction of the tribe to which the member belongs; or," (Okla. Admin. Code § 710:50-15-2)

Although the code appears to be cut and dried, the tax commission decided that their own judge got it wrong and rejected Stroble's appeal. After the tax commission decision, an appeal was filed, and the Oklahoma Supreme Court decided to retain the case instead of assigning it to the Oklahoma Court of Civil Appeals. The Muscogee (Creek) Nation, Seminole Nation, Cherokee Nation, Chickasaw and Choctaw Nation have all filed briefs supporting Stroble in the case.

The Oklahoma Supreme Court has not decided at this stage whether oral arguments will be heard

in the case or if the justices will simply decide the matter based on the briefs. Mvskoke Media will report the court's decision as soon as it is available.

Bacone College

Bacone College has been put on heightened cash monitoring by the U.S. Department of Education. Heightened cash monitoring is instituted by the department when colleges or universities have a number of financial or federal compliance issues. Bacone was placed on Heightened Cash Monitoring 1 (HCM1) on March 1 of this vear.

There are two levels of heightened cash monitoring. The first, HCM1 occurs when a school makes disbursements to eligible students from institutional funds. The disbursement records are submitted to the Common Origination and Disbursement (COD) System. Federal Student Aid funds are used to cover those disbursements.

The second, HCM2 is where a school no longer receives funds under the Advance Payment Method. After disbursements are made to students from an institution's own funds, a Reimbursement Payment Request must be submitted to supply the funds.

Higher learning institutions can be placed on HCM1, or HCM2 due to a number of issues. These can include late or missing annual financial statements,

audits, outstanding liabilities, denial of re-certifications, concerns about the school's administrative capabilities or concerns around a school's financial responsibility.

Academic institutions on heightened cash monitoring can be searched by quarter on the FSA website.

Institutions also receive annual composite scores from the DOE that reflect their overall relative financial health. These are referred to as Financial Responsibility Composite Scores, and are scored on a scale of negative one to positive three.

Financial Bacone's Responsibility Composite Score was reported as a 1.4 for the 2020-2021 financial year, the last financial year the composite scores were published.

Mvskoke Media previously reported on a Higher Learning Commission accreditation complaint filed by a former Bacone employee against the college. This complaint alleged that Bacone had Clery Act violations that had resulted in a \$200,000 fine. Mvskoke Media has since received a statement from a spokesperson at the Department of Education on the fines.

According to the statement, "As of October 2022, the fine is still pending. Fines are not reported on the public page until they are imposed."

Mvskoke Media will continue to monitor these stories and publish updates when available.

School: Epic Charter Schools



School: Ada High School



School: Okmulgee High School



Yafke-Kolvswa Marks


School: College of the Muscogee Nation

School: Union High School



Colton Lane "Colt" Patterson


School: Coweta High School

School: University of Tulsa




Zachary Show

School: Bixby High School




Joseph Youmans
